I urge you to support the Tobacco Settlement Fund request from Marshall Medical Center and Marshall Foundation on next Tuesday's agenda.

The Tobacco Settlement Fund was initiated based on a court decision that tobacco use causes cancer and other health related issues. Yet only 10% of these funds are dedicated to health related issues. 90% of these funds go into the county general fund. When you consider the basis of the decision, logic would dictate that 100% of the funds should go to health related issues, especially those directly related to tobacco use.

Since El Dorado County does not have a county hospital, Marshall and Barton provide that service. They care for everyone who walks through their doors.

Supporting the Marshall Cancer Center is a way for El Dorado County to care for its citizens. It is a way for you to serve your constituents by allowing them to receive medical service close to home rather than sending them out of the county. I urge you to do the right thing and help your constituents by supporting Marshall Medical Center.

Dear Supervisor Briggs,

Thank you for hearing the petition from Marshall Medical Center to use a portion of the Tobacco Settlement money to support the Marshal Cancer Resource Center in El Dorado County. I urge the Board to support the proposal, and I thank you in advance for your serious consideration.

To me, there are several compelling reasons to award \$800,000 in support of Marshall's Cancer Center in Cameron Park. First, El Dorado County has the oldest population in all of the counties in California, with cancer being the leading cause of death. The economic vitality of EDC is greatly enhanced with seniors choosing to retire here and to invest in our community with both their time and their financial resources. Having a local, independent hospital with a trusted Cancer Center in the heart of the Western Slope makes EDC a viable choice for active seniors in their retirement years.

Secondly, the medical industry has been identified as being one of the most promising economic development clusters for EDC. Having a thriving, expansive independent hospital in the heart of the County that is flexible and collaborative is an important factor in attracting the high paying jobs that the boutique medical industry creates. The presence of Stem Express in Placerville is a perfect example of the types of opportunities that exist, and they are working collaboratively with MMC.

Thirdly, Marshal is one of the largest employers in El Dorado County, and by supporting the Cancer Center, you are ensuring that jobs that pay a living wage are created and expanded.

Finally, there is a natural nexus between the Tobacco Settlement money and the need to expand Marshall's Cancer Center. The Settlement funds were established to help offset tobacco-related health care costs. While I realize you have many demands within the Health and Human Services Department, cancer is one of the leading results of tobacco use, and Marshall Medical Center is the entity that deals directly with these effects.

While Marshall is a strong organization, they cannot care for our community alone. I thank you for your support in ensuring that Marshall Medical Center has the means to continue to be the sole, full-service health care provider on the Western Slope of El Dorado County, keeping our residents close to the services they need and desire.
