I oppose the Town Center Apartment project for numerous reasons, most of which have been noted by others. Project density, height of structures, not properly covered by EIR. I'm also troubled by the report by future planning on the traffic impact being reduced. When I see one calculation in a report that is invalid, it makes me question everything in the report. The report states that under the currently approved use a hotel of 100 rooms would generate:

"Daily rate: 8.92 trips per occupied room= 892 daily trips". What is the average occupancy rate of hotels in El Dorado County?/or Folsom/ or Sac. Region? I guarantee it's not 100% as these calculations suggest. What else is wrong with the reports. The outside firm of Fehr & Peers used for the analysis. Who commissioned them and paid for their services?

The planning department is obviously pushing very hard for this project that asks for extreme exceptions to the General Plan as well as the Specific Plan. Please deny this project and confirm the proper process of following the General Plan and completing Specific Plans as previously approved.

I think the idea of putting in apartments on the Highway side of Town Center really makes sense. I have talked to several residents of El Dorado Hills who think it would really add to the amenities offered by El Dorado Hills.

However, I am opposed to the number of units planned which push the elevation of both the apartment blocks and the parking structure to heights that are unacceptable. I have spent some time looking at the site from the movie theater, the Thai restaurant, the walkway and from across the freeway. If it were to be 120 units, bringing the number of floors down to no more than 3, it would be acceptable. There must be a way to meet the communities housing needs and not end up with such a sight (as well as site) blocking development.
