

### RESOLUTION NO. 217-2014

#### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

#### (REPEALING RESOLUTION NO. 47-2011)

WHEREAS, the California Code of Regulations, Title 24, Part 9, the California Fire Code, is updated by the State every three years; and,

WHEREAS, the 2013 California Fire Code became effective on January 1, 2014; and,

WHEREAS, local jurisdictions may establish more restrictive building standards reasonably necessary because of local climatic, geological or topographical conditions; and,

WHEREAS, the California Code of Regulations, Health and Safety Code, Division 12, Part 2, Chapter 1, Article 2, Section 13146, assigns responsibility for enforcement of fire safety regulations to the local level and grants authority to delegate enforcement to the drief building official, or his or her authorized representative, or to the chief of the fire protection district, or his or her representative; and,

WHEREAS, enforcement of the Fire Code in the County of El Dorado has historically been shared by the County Building Official and the local Fire Agencies according to the knowledge and skills each possesses; and,

WHEREAS, on December 9, 2013, the Board of Directors of the Latrobe Fire Protection District adopted Ordinance No. 01-11-01 which adopted the 2013 California Fire Code with amendments the District deemed necessary to deal with local climate, geological or topographical conditions.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Supervisors of the County of El Dorado ratifies the following building code Amendments to the California Fire Code adopted by Latrobe Fire Protection District:

# ORDINANCE No. 01-11-01

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE LATROBE FIRE PROTECTION DISTRICT AS FOLLOWS:

AN ORDINANCE OF THE LATROBE FIRE PROTECTION DISTRICT ADOPTING THE 2013 EDITION OF THE CALIFORNIA FIRE CODE, BASED UPON THE 2012 EDITION OF THE INTERNATIONAL FIRE CODE, REGULATING AND GOVERNING THE SAFEGUARDING OF LIFE AND PROPERTY FROM FIRE AND EXPLOSION HAZARDS ARISING FROM THE STORAGE, HANDLING AND USE OF HAZARDOUS SUBSTANCES, MATERIALS AND DEVICES, AND FROM CONDITIONS HAZARDOUS TO LIFE OR PROPERTY IN THE OCCUPANCY OF BUILDINGS AND PREMISES IN THE LATROBE FIRE PROTECTION DISTRICT; PROVIDING FOR THE ISSUANCE OF PERMITS AND COLLECTION OF FEES THEREFORE; REPEALING ORDINANCE NO. XX OF THE LATROBE FIRE PROTECTION DISTRICT AND ALL OTHER ORDINANCES AND PARTS OF THE ORDINANCES IN CONFLICT THEREWITH.

#### **SECTION 1: FINDINGS:**

The Latrobe Fire Protection District makes certain changes (listed below) to the California Fire Code, 2013 Edition, pursuant to Health and Safety Code Section 13869.7, 17958.7 and 18941.5 during this code adoption process. Such changes are necessary because of local climatic, geological and/or topographic conditions. The Latrobe Fire Protection District has adopted, pursuant to Section 18941.5 of the California Health and Safety Code, the findings of facts relative to these conditions by Resolution Girilia of the Latrobe Fire Protection District dated \(\frac{11116}{21116}\).

These changes include amendments and additions to the California Fire Code in the following sections:

# **SECTION 2: ADOPTION OF CODE:**

That a certain document, three (3) copies of which are on file in the office of the Secretary of the Board of Directors of the EDHCWD (Fire Department), being marked and designated as the California Fire Code, 2013 edition, in its entirety, and the following International Fire Code Sections and Appendices not adopted by the State of California; 101.1 thru 101.5, 102.6 thru 102.8, 102.10 thru 102.12, 103.1 thru 104.1, 104.3 thru 104.4, 104.6 thru 104.6.4, 104.8, thru 104.9.2, 104.10.1 thru 104.11.3, 105.2.3, 105.3.1 thru 105.3.2, 105.6.9, Table 105.6.10, 105.6.12, 105.6.16 thru 105.6.19, 105.6.27 thru 105.6.42, 105.6.44 thru 105.6.45, 105.7.15 thru 105.7.16, 106.1, 107.1 thru 108.3, 109.3.2 thru 109.4.1, 112.1, 113.1 thru 115.5, 303.1 thru 303.9, 305.1 thru 305.4, 307.1, thru 307.5, 308.1 thru 308.5, 408.1 thru 408.11.3, 503, and Appendix F, J, and K, based on the 2012 edition of the International Fire Code as published by the International Code Council and the 2013 California Fire Code, be and is hereby adopted as the Fire Code of the Latrobe Fire Protection District, in the State of California regulating and governing the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises as herein provided; providing for the issuance of permits and collection of fees therefore; and each and all of the regulations, provisions, penalties, conditions and terms of said Fire Code on file in the office of the Latrobe Fire Protection District are hereby referred to, adopted, and made a part hereof, as if fully set out in this ordinance, with the additions, insertions, deletions and changes, if any, prescribed in Section 3 of this ordinance.

#### SECTION 3: CALIFORNIA FIRE CODE, AMENDMENTS:

The following Sections are hereby amended or added:

California Fire Code, Chapter 1 Amendments - Scope and Administration:

Section 105 - Permits

Section 105.6.26 is amended as follows: LP Gas.

Section 105.6.27 of Chapter 1 of the Fire Code of the Latrobe Fire Protection District is amended to read as follows:

#### 105.6.27 - LP Gas

1. Storage and use of LP-gas.

Exception: A permit is not required for individual containers with a 500 100 gallon water capacity or less serving occupancies in Group R-3.

#### Section 109 - Violations

#### Section 109.4 is amended as follows: Violation penalties.

Section 109.4 of Chapter 1 of the Fire Code of the Latrobe Fire Protection District is amended to read as follows:

Section 109.4 Violation penalties. Persons who shall violate a provision of this code or shall fail to comply with any of the requirements thereof or who shall erect, install, alter, repair or do work in violation of the approved construction documents or directive of the fire code official, or of a permit or certificate used under provisions of this code, shall be guilty of a misdemeanor, punishable by a fine of not more than \$1000.00 and/or by imprisonment not exceeding 6 months, or both such fine and imprisonment. Each day that a violation continues after due notice has been served shall be deemed a separate offense. (Health & Safety Code Section 13145 and 17995).

# Section 111 - Stop Work Orders

# Section 111.4 is amended as follows: Failure to comply.

Section 111.4 of Chapter 1 of the Fire Code of the Latrobe Fire Protection District is amended to read as follows:

111.4. Failure to comply. Any person who shall continue any work after having been served with a stop work order, except such work as that person is directed to perform to remove a violation or unsafe condition, shall be liable to a fine of not less than \$500 or not more than \$1,000. (Health & Safety Code Section 13145 and 17995).

#### Section 113.6 and 113.6.1 are added as follows: Fees.

Sections 113.6 and 113.6.1 of Chapter 1 of the Fire Code of the Latrobe Fire Protection District are added to read as follows:

113.6 Permit, Plan Review and Inspection Fees. A schedule of fees adopted by the Fire District Board of Directors for Plan Review, Inspections and the issuance of Permits by the Fire District may be found in the most current Latrobe Fire Protection District fee schedule (Health & Safety Code 17951).

113.6.1 Cost Recovery Fees. Fire service fees may be charged to any person, firm, corporation or business that through negligence, violation of the law, or as a result of carelessness, is responsible for the cause of the Fire District to respond to the scene of an incident. A district board may charge a fee to cover the cost of any service which the district provides or the cost of enforcing any regulation for which the fee is charged. (Health and Safety Code 13916). The fee shall not exceed the actual cost of suppressing the fire and/or responding to the scene of an incident.

# California Fire Code, Chapter 5 Amendments – Fire Service Features

#### Section 503 - Fire Apparatus Access Roads

Section 503 of the Fire Code of the Latrobe Fire Protection District is adopted and amended to read as follows:

503.1 Where required.

Fire apparatus access roads shall be provided and maintained in accordance with <u>Sections 503.1.1</u> through <u>503.1.3.</u>

503.1.1 Buildings and facilities.

Approved fire apparatus access roads shall be provided for every facility, building or portion of a building hereafter constructed or moved into or within the jurisdiction. The fire apparatus access road shall comply with the requirements of this section and shall extend to within 150 feet (45 720 mm) of all portions of the facility and all portions of the exterior walls of the first story of the building as measured by an approved route around the exterior of the building or facility.

Exception: The fire code official is authorized to increase the dimension of 150 feet (45 720 mm) where:

- 1. The building is equipped throughout with an approved automatic sprinkler system installed in accordance with Section 903.3.1.1, 903.3.1.2 or 903.3.1.3.
- 2. Fire apparatus access roads cannot be installed because of location on property, topography, waterways, nonnegotiable grades or other similar conditions, and an *approved* alternative means of fire protection is provided.
- 3. There are not more than two Group R-3 or Group U occupancies.

#### 503.1.2 Additional access.

The fire code official is authorized to require more than one fire apparatus access road based on the potential for impairment of a single road by vehicle congestion, condition of terrain, climatic conditions or other factors that could limit access.

503.1.3 High-piled storage.

Fire department vehicle access to buildings used for high-piled combustible storage shall comply with the applicable provisions of Chapter 32.

503.2 Specifications.

All fire apparatus access roads shall be installed and arranged in accordance with Sections 503.2.1

through 503.2.8.

[California Code of Regulations, Title 19, Division 1,§3.05(a)] Fire Department Access and Egress. (Roads)

(a) Roads. Required access roads from every building to a public street shall be all-weather hardsurfaced (suitable for use by fire apparatus) right-of-way not less than 20 feet (6096 mm) in width. Such right-of-way shall be unobstructed and maintained only as access to the public street.

Exception: The enforcing agency may waive or modify this requirement if in his opinion such all-weather hard surfaced condition is not necessary in the interest of public safety and welfare.

#### 503.2.1 Dimensions.

For one and two family dwelling units (R3) applications, fire apparatus access roads shall have an unobstructed width of not less than 20 feet (6096 mm) than 18 feet, plus one foot shoulder on each side, except for approved security gates in accordance with Section 503.6, and an unobstructed vertical clearance of not less than 13 feet 6 inches (4115 mm). This conforms with Title 14 SRA Fire Safe Regulations as adopted by El Dorado County Section 1273.01.

For applications other than (R3), fire apparatus access roads shall have an unobstructed width of not less than 20 feet, plus one foot shoulder on each side, except for approved security gates in accordance with Section 503.6, and an unobstructed vertical clearance of not less than 13 feet 6 inches (4115 mm) or as approved by the fire code official.

All Driveways as defined by Title 14 SRA Fire Safe Regulations as adopted by El Dorado County shall be not less than 12 feet wide.

#### 503.2.2 Authority.

The fire code official shall have the authority to require an increase in the minimum access widths where they are inadequate for fire or rescue operations.

#### 503.2.3 Surface.

Fire apparatus access roads shall be designed and maintained to support the imposed loads of fire apparatus and shall be surfaced so as to provide all-weather driving capabilities. All weather surfaces shall be asphalt, concrete or other approved driving surface.

#### 503.2.4 Turning radius.

The required turning radius of a fire apparatus access road shall be determined by the fire code official.

#### 503.2.5 Dead ends.

For one and two family dwelling units (R3) applications, dead-end fire apparatus access roads shall comply with Title 14 SRA Fire Safe Regulations as adopted by El Dorado County Section 1273.09 and shall have a turnaround constructed at its terminus.

For applications other than (R3), dead-end fire apparatus access roads in excess of 150 feet (45 720 mm) in length shall be provided with an approved area for turning around fire apparatus.

503.2.6	Bridges	and	elevated	surfaces.

Where a bridge or an elevated surface is part of a fire apparatus access road, the bridge shall be

constructed and maintained in accordance with the current El Dorado County Transportation Division bridge standard. Bridges and elevated surfaces shall be designed for a live load sufficient to carry the imposed loads of fire apparatus. Vehicle load limits shall be posted at both entrances to bridges when required by the *fire code official*. Where elevated surfaces designed for emergency vehicle use are adjacent to surfaces which are not designed for such use, *approved* barriers, *approved* signs or both shall be installed and maintained when required by the *fire code official*.

#### 503.2.7 Grade.

The grade of the fire apparatus access road shall be within the limits established by the *fire code* official based on the fire department's apparatus.

503.2.8 Angles of approach and departure.

The angles of approach and departure for fire apparatus access roads shall be within the limits established by the *fire code official* based on the fire department's apparatus.

503.3 Marking.

Where required by the *fire code official, approved* signs or other *approved* notices or markings that include the words NO PARKING—FIRE LANE shall be provided for fire apparatus access roads to identify such roads or prohibit the obstruction thereof. The means by which *fire lanes* are designated shall be maintained in a clean and legible condition at all times and <u>shall</u> be replaced or repaired when necessary to provide adequate visibility.

503.4 Obstruction of fire apparatus access roads.

Fire apparatus access roads shall not be obstructed in any manner, including the parking of vehicles. The minimum widths and clearances established in Section 503.2.1 shall be maintained at all times.

503.4.1. Traffic calming devices.

Traffic calming devices shall be prohibited unless approved by the fire code official.

503.4.2 Fire Apparatus Access Gates

Fire Apparatus Access Road Gates shall meet the standards identified in the Fire Department's Gate Standard.

503.4.3 Roads from 20 to 29 feet in width.

Section 503.4.3 of the Fire Code of the Latrobe Fire Protection District is amended to read as follows:

503.4.3 Roads from 20 to 29 feet in width. Fire apparatus access roads, 20 to 29 feet wide, shall be posted on both sides as a fire lane, with no parking allowed on either side of the roadway.

Section 503.4.4 shall be amended as follows: Roads from 30 to 35 feet in width.

Section 503.4.4 of the Fire Code of the Latrobe Fire Protection District is amended to read as follows:

503.4.4 Roads from 30 to 35 feet in width. Fire apparatus access roads, 30 to 35 feet wide, shall be posted on one side as No Parking, Fire Lane, with parking allowed only on the opposite side of the roadway.

# Section 503.4.5 shall be added as follows: Roads 36 feet and greater in width.

Section 503.4.5 of the Fire Code of the Latrobe Fire Protection District is added to read as follows:

503.4.5 Roads 36 feet and greater in width. Fire apparatus access roads, 36 feet and greater in width, may allow parking on both sides of the roadway.

#### 503.5 Required gates or barricades.

The *fire code official* is authorized to require the installation and maintenance of gates or other approved barricades across fire apparatus access roads, trails or other accessways, not including public streets, alleys or highways. Electric gate operators, where provided, shall be *listed* in accordance with UL 325. Gates intended for automatic operation shall be designed, constructed and installed to comply with the requirements of ASTM F 2200.

# 503.5.1 Secured gates and barricades.

When required, gates and barricades shall be secured in an *approved* manner. Roads, trails and other accessways that have been closed and obstructed in the manner prescribed by <u>Section 503.5</u> shall not be trespassed on or used unless authorized by the *owner* and the *fire code official*.

Exception: The restriction on use shall not apply to public officers acting within the scope of duty.

503.5.2 Fences and gates. School grounds may be fenced and gates therein may be equipped with locks, provided that safe dispersal areas based on 3 square feet (0.28 m²) per occupant are located between the school and the fence. Such required safe dispersal areas shall not be located less than 50 feet (15 240 mm) from school buildings. Every public and private school shall conform with Section 32020 of the Education Code, which states: The governing board of every public school district, and the governing authority of every private school, which maintains any building used for the instruction or housing of school pupils on land entirely enclosed (except for building walls) by fences or walls, shall, through cooperation with the local law enforcement and fire-protection agencies having jurisdiction of the area, make provision for the erection of gates in such fences or walls. The gates shall be of sufficient size to permit the entrance of the ambulances, police equipment and fire-fighting apparatus used by the law enforcement and fire-protection agencies. There shall be no less than one such access gate and there shall be as many such gates as needed to assure access to all major buildings and ground areas. If such gates are to be equipped with locks, the locking devices shall be designed to permit ready entrance by the use of the chain or bolt-cutting devices with which the local law enforcement and fire-protection agencies may be equipped.

### 503.6 Security gates.

The installation of security gates across a fire apparatus access road shall be approved by the fire chief. Where security gates are installed, they shall have an approved means of emergency operation. The security gates and the emergency operation shall be maintained operational at all times. Electric gate operators, where provided, shall be listed in accordance with UL 325. Gates intended for automatic operation shall be designed, constructed and installed to comply with the requirements of ASTM F 2200.

The Following Sections of the California Fire Code, Appendix D – Fire Apparatus Access Roads are adopted and amended to read as part of Chapter 5 as follows:

### 503.7 Commercial And Industrial Developments

- 503.7.1 Buildings exceeding three stories or 30 feet in height. Buildings or facilities exceeding 30 feet (9144 mm) or three stories in height shall have at least two means of fire apparatus access for each structure.
- 503.7.2 Buildings exceeding 62,000 square feet in area. Buildings or facilities having a gross building area of more than 62,000 square feet (5760 m<sup>2</sup>) shall be provided with two separate and approved fire apparatus access roads.
- 503.7.3 Remoteness. Where two access roads are required, they shall be placed a distance apart equal to not less than one half of the length of the maximum overall diagonal dimension of the property or area to be served, measured in a straight line between accesses.

Exception: Fire apparatus roads cannot be installed because of location on property, topography, waterways, nonnegotiable grades or similar condition, and an approved alternative means of fire protection is provided.

#### 503.8 Aerial Fire Apparatus Access Roads

- 503.8.1 Where required. Buildings or portions of buildings or facilities exceeding 30 feet (9144 mm) in height above the lowest level of fire department vehicle access shall be provided with approved fire apparatus access roads capable of accommodating fire department aerial apparatus. Overhead utility and power lines shall not be located within the aerial fire apparatus access roadway.
- 503.8.2 Width. Aerial fire apparatus access roads shall have a minimum unobstructed width of 26 feet (7925 mm), exclusive of shoulders, in the immediate vicinity of any building or portion of building more than 30 feet (9144 mm) in height.
- 503.8.3 Proximity to building. At least one of the required access routes meeting this condition shall be located within a minimum of 15 feet (4572 mm) and a maximum of 30 feet (9144 mm) from the building, and shall be positioned parallel to one entire side of the building.

#### 503.9 Multiple-Family Residential Developments

503.9.1 Projects having more than 100 dwelling units. Multiple-family residential projects having more than 100 dwelling units shall be equipped throughout with two separate and approved fire apparatus access roads.

#### 503.10 One- or Two-Family Residential Developments

Section 507 – Fire Protection Water Supplies

503.10.1 One- or two-family dwelling residential developments. Developments of one- or two-family dwellings shall be provided with separate and approved fire apparatus access roads and shall meet the requirements of 503.7.3 Remoteness, when required by the Fire Chief.

Sections 507.5.1 of Chapter 5 of the Fire Code of the Latrobe Fire Protection District are amended to read as follows:

#### Section 507.5.1 is amended to read as follows:

Section 507.5.1 Where required. Where a portion of the facility or building hereafter constructed or moved into or within the jurisdiction is more the 400 150 feet from a hydrant on a fire apparatus access road, as measured by an approved route around the exterior of the facility or building, on-site fire hydrants and mains shall be provided where required by the fire code official.

#### Exception:

1. For Group R-3 and Group U occupancies, equipped throughout with an approved automatic sprinkler system installed in accordance with Section 903.1, the distance requirement shall be not more than 600 feet (183 m).

# California Fire Code, Chapter 6 Amendments - Building Services and System

#### Section 604 - Emergency and Standby Power Systems

Sections 604.1 of Chapter 6 of the Fire Code of the Latrobe Fire Protection District are amended to read as follows:

# Section 604.1 is Amendment as follows:

#### **SECTION 5: CONFLICT**

That Ordinance No. XX of the Latrobe Fire Protection District, and all other ordinances or parts of ordinances herewith are hereby repealed.

### **SECTION 6: SEVERABILITY**

If any Ordinance, article, subsection or subdivision thereof, provision, sentence, clause or phrase of this code, or any application thereof, is for any reason held to be invalid by a court of competent jurisdiction, such decision shall not affect the remaining provisions of this code, which can be given effect without the invalid portions and, therefore, such invalid portions are declared to be severable. The Latrobe Fire Protection District hereby declares that it would have enacted this Ordinance and each of its articles, sections, subsections, or subdivisions thereof, provisions, sentences, clauses or phrases irrespective of the fact that one or more of them is declared invalid.

# ADOPTING FINDINGS SUPPORTING AMENDMENTS TO THE FIRE CODE

#### LATROBE FIRE PROTECTION DISTRICT

WHEREAS, the District intends to adopt an ordinance adopting the California Fire Code, 2007 Edition, and prescribing regulations governing conditions hazardous to life, property and the environment from fire, explosion, hazardous materials and hazardous uses; and

WHEREAS, the unique local climatic geological, and topographical conditions existing within the boundaries of the District make it reasonably necessary for the District to impose more stringent requirements than set forth in the California Fire Code and pursuant to California Health and Safety Code sections 13869.7 and 17958.7, the District desires to make express findings to that effect.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Latrobe Fire Protection District hereby adopts the following findings concerning current unique local conditions that together make each modification to the California Fire Code, 2007 Edition, reasonably necessary to provide adequate and effective protection of life, property and the environment.

A. General. After due consideration, the Board of Directors of the Latrobe Fire Protection District, hereby finds that due to local climatic, geologic and topographic conditions, as stated within this document, there is a need to provide the modifications and changes contained in the adoptive Ordinance of the 2007 California Fire Code. Such changes are deemed to be reasonably necessary to provide adequate and effective protection of life, property and the environment.

The Latrobe Fire Protection District provides fire protection, emergency medical services and specialized rescue services to approximately one thousand people in a 35 square mile area. The District is located on the western slope of El Dorado County. The topography of the District ranges from valley grasslands in the south/west to rolling hills of grass and oak woodland in the north and east. The weather conditions vary from near freezing temperatures with very occasional light snow in winter, to summer temperatures

that regularly exceed 100 degrees. During winter heavy periods of Tule fog are probable which severely impacts visibility and can impact timely response, especially from our neighboring agencies.

The Latrobe Fire Protection District is an "all-risk" agency. The District participates in a sophisticated automatic aid program and is dispatched through agreement by the California Department of Forestry and Fire Protection (Cal-Fire), at Camino. The resources of the District will respond to, and deal with, any type of emergency. The term "Fire Protection" in this document is broad and includes responses to fires, smoke and odor investigations, alarms, public assist calls, hazardous materials incidents, medical aid and specialized rescues.

The District has established one, part-time, staffed fire station and one volunteer fire station to provide emergency services to the community. Fire Station 91 is located in the township of Latrobe, at 7660 South Shingle Road. Fire Station 92, a volunteer station, is located in the west end of the district at Ryan Ranch and Beaver Pond Roads. The District has 6 part-time personnel and 15 volunteer firefighter positions, along with three chief officers.

- Climatic. The Latrobe Fire Protection District is located within a foothill region. The B. District is subject to four seasons; with an annual average snow fall in the winter months of less than 2 inches, in addition to an average rainfall of 25 inches per year. Many times during the winter months the roads of the district can experience black ice conditions. There are a number of seasonal streams in the district with limited bridges or culverts. During summer months the district can experience very intense Northern Winds, often exceeding 40 to 60 miles per hour with humidity's in the single digits. These adverse weather conditions create severe hazardous road conditions along the main access roads within, as well as into, the District from the surrounding areas. Due to periods of rainfall, Tule fog and black ice, the ability of the Fire Protection District to provide immediate emergency response is often delayed. These same adverse climatic conditions often result in a number of vehicular accidents that place extreme restraints on the availability of emergency response to perform emergency rescue, first aid, hazardous materials control and fire fighting. The climatic conditions often result in a substantial or total lack of ability of the Fire Protection District to respond immediately to other types of emergency situations that occur. Examples of these emergency situations include structure fires, wildland and forest fires, hazardous materials incidents, emergency medical calls, vehicle accidents and vertical rescues. The mutual aid agreements established with adjoining fire agencies might not be possible due to adverse climatic conditions, restricting or totally blocking access into the District.
- C. Geological. The Latrobe Fire Protection District is located within moderate activity seismic Zone Three. The seismic, geological conditions present a potential for multiple fires, major breakage of water mains, multiple electrical power failures, multiple collapsed structures and a large number of calls for emergency medical aid, all of which may occur simultaneously during a seismic event. The water district has numerous water-pumping systems used for fire suppression water delivery, as well as water storage tanks providing water system pressure. Most of the pumping systems are dependent on electrical power for operation. Such electrical power may not be available during a seismic event. Water storage tanks used for the storage of required fire suppression water may also collapse in such an event forcing the additional needs to transport water via

additional pieces of fire apparatus which will place a significant restraint on the ability of the District to provide the required emergency services.

D. Topographical. The District is primarily composed of areas that are considered by the State fire hazard severity zone mapping system to be of very high fire severity zones and wildland. Much of the District is located within foothill terrain, covered with highly combustible vegetation. The elevation within the District ranges from at 100 feet to over 1,300 feet at the highest point. Slope within the District ranges from 0 degrees to 90 degrees. The structures within the areas of foothills terrain have very limited fire access, due to narrow roadways with steep grades and poor road surface conditions. The presence of many existing structures within the very high fire hazard severity zone areas provides for a very high potential of a structure fire spreading into a wildland or forest fire condition as well as the potential for a wildland or forest fire spreading to structures.
