The Board of Supervisors Have Lost the Public Trust

I note that today on consent Item 27 two Boy Scouts have achieved the highest rank in Scouting, Eagle Scout. As a former Scout and United States Marine I would like to congratulate them for their achievement.

The Boy Scouts are notable in that they live by the Scout Law. Among these laws, the first and most important is to be Trustworthy. Quoting from my Boy Scout Handbook:

"TRUSTWORTHY – A Scout's honor is to be trusted. If he were to violate his honor by telling a lie or by cheating or by not doing exactly a given task, when trusted on his honor, he may be directed to hand over his Scout badge." (unquote)

Board, you are not Boy Scouts, but you did take an oath of office which swore you to uphold the Constitution of the United States and the State of California. A solemn oath is giving your word of honor that you uphold the public Trust. There is that word again.

On July 29th 2014 in this very chamber you violated the public trust by denying the right to vote on Measure Y to the citizens in this County even though you had given your word and sworn an oath to do so.

On August 5th 2014 in this very spot dozens of people spoke up and showed you a way to correct that mistake. You ignored those pleas. I myself stayed here until the end of the business day and itemized all of the Constitutional violations and listed the County Ethics violations which you had committed to by denying us the vote. Again I pleaded with you to correct your error and begin to restore the public trust. But once more you refused to allow equal justice under the law to the citizens of El Dorado County.

Quoting again from my Boy Scout Manual: "All our dealings with other people are based on trust. We drop a letter in the mailbox and trust the
