

## **RESOLUTION NO.**

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS,** Welfare and Institutions Code (WIC) Section 5150(a) provides that the attending staff of a County designated evaluation facility or other professional persons designated by the County, may upon probable cause, take or cause to be taken into custody and placed in an approved 72-hour evaluation and treatment facility, any person who is gravely disabled or as a result of mental disorder is a danger to self or others; and

**WHEREAS**, Resolution xxx-2014 adopted by the Board of Supervisors on November 4, 2014, delegates to the Health and Human Services Agency Mental Health Director, the authority to carry out the responsibilities and functions of the Board with respect to the Psychiatric Health Facility, the Adult System of Care, and the Children's System of Care as specified in CCR Title 22 Section 77081; and

**WHEREAS**, on November 4, 2014, the Board approved Agreement for Services 221-S1511 with Telecare Corporation, Inc. to operate the Psychiatric Health Facility; and

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado hereby designates the Psychiatric Health Facility of El Dorado County operated under contract with the County by Telecare Corporation, Inc., as an evaluation and treatment facility in accordance with Welfare and Institutions code Section 5150(a).

**NOW THEREFORE, BE IT FURTHER RESOLVED** that the Board hereby designates the following classes of persons working for Telecare Corporation, Inc., as "other professional persons" under Welfare and Institutions Code Section 5150, while such people are on duty at the Psychiatric Health Facility:

- 1. Psychiatrists employed by Telecare;
- 2. Consulting Psychiatrists contracted by Telecare Corporation to provide services at the Psychiatric Health Facility of El Dorado County;
- 3. Physicians, Licensed Psychologists, Licensed Clinical Social Workers, and Marriage and Family Therapists working for Telecare Corporation;
- 4. The following Telecare Corporation employees and agency staff contracted with Telecare Corporation:
  - a. Nurse Practitioners;
  - b. Licensed and Registered Psychologists;
  - c. Licensed Clinical Social Workers;
  - d. Licensed Marriage & Family Therapists;
  - e. Registered Nurses;
  - f. Licensed Psychiatric Technicians;
  - g. Licensed Vocational Nurses;
  - h. Mental Health Rehabilitation Specialists.

**BE IT FURTHER RESOLVED** that all professional persons designated by the County shall attend and complete initial training and certification procedures, and thereafter attend required training as determined by the Health and Human Services Agency Mental Health Director, in order to acquire and retain the authority granted herein.
