GRANT OF EASEMENT

EL DORADO IRRIGATION DISTRICT, hereinafter called GRANTOR, does hereby grant to EL DORADO COUNTY, its successors and assigns, hereinafter called GRANTEE, permanent floating easement and rights-of-way easement for ingress and egress purposes and appurtenances and uses commonly associated therewith (including but not limited to maintenance and repair), over, along, across, and through any of that certain real property situated in the County of El Dorado, State of California and depicted in the attached Exhibit A ("Easement Area").

This grant of easements includes all existing vehicular and other access ways over, along, across, and through the Easement Area, and any such expanded or replacement access ways as are mutually agreed to in writing by the parties' authorized representatives, and shall include the right by GRANTEE, its officers, agents and employees, and by persons under contract with it and their employees whenever and wherever necessary for ingress and egress purposes, to enter upon the Easement Area with personnel, vehicles and equipment for access to and maintenance of both the Easement Area and property owned by GRANTEE located adjacent to GRANTOR's Property.

This grant of easement is subject to the following conditions, which are intended by each party to be, and shall be, covenants running with their respective lands such that successive owners of the respective lands are bound thereby for the benefit of the other lands, as authorized by California Civil Code section 1468:

- 1. GRANTEE's use of the Easement Area pursuant to this Grant of Easement shall not endanger health, create a nuisance, or otherwise be incompatible with overall recreation use of GRANTEE's and GRANTOR's respective lands.
- 2. GRANTEE shall take all reasonable precautions to ensure that the construction, operation, and maintenance of structures or facilities in the Easement Area will occur in a manner that will protect the scenic, recreational, and environmental values of GRANTEE's and GRANTOR's respective lands. Ground disturbing activities that occur within the Easement Area are subject to compliance with Section 106 of the National Historic Preservation Act.
- 3. At such time as GRANTOR's planned Forebay Dam Modification Project is substantially complete and in service, GRANTOR shall submit revised Exhibit G drawings to the Federal Energy Regulatory

Commission ("FERC") to exclude the Easement Area from the project area of Hydroelectric Project No. 184, and make best efforts to obtain expeditious FERC approval of the revised drawings and project area.

4. Following FERC approval as specified in paragraph 3, GRANTOR shall execute a quitclaim deed to convey fee ownership of the Easement Area to GRANTEE.




