	(page SP-78)	"In lieu of using material for stump chipping or grinding operation, wood chip mulch for revegetation items, Contractor has the option to use wood chips from a source in the Tahoe Basin. The source shall be approved by the Engineer. All hauling and costs associated with import of wood chip mulch material shall be included in the various items of work and no additional compensation will be made therefor."
