Dear Jim,

This letter will confirm that El Dorado County HFH has been added to the roster of exempt subordinates included in the group exemption letter of Habitat for Humanity International, Inc. ("HFHI") under section 501(c)(3) of the Internal Revenue Code, effective on December 1, 1996.

The enclosed copy of the group exemption letter received from the IRS (dated April 27, 1990) provides evidence of HFHI's group exemption. That letter, together with this letter which confirms your affiliate's exempt subordinate status, provide evidence of your tax exempt status under section 501(c)(3) of the code.
