
Thank you for taking your time to attend our Serrano town hall meeting regarding the Silva Valley Interchange and the County's proposal to eliminate left turns onto Silva Valley Parkway from Entrada Drive and from Oak Meadow School. As you heard at that meeting, the residents of our community are very concerned about the potential impacts of this proposal on their safety and their quality of life.

The Serrano El Dorado Owner's Association Board of Directors has deep concerns about whether the proposed solution is the best solution for the anticipated problem that will be caused by increased traffic once the interchange opens. We strongly urge the Board of Supervisors to delay any action on this proposal until the potential impacts of this proposal and all reasonable alternatives have been fully evaluated. Additionally, was this proposal in the CEQA document for the interchange project? Once that work is completed, we urge you to arrange another town hall meeting to discuss the results.

County of Transportation Division staff confirmed (to us) that they will be asking the Board of Supervisors for authorization to study the matter further prior to making any recommendations, as prompted by the concerns expressed by our members. The safety of our residents and guests is at risk and the property values throughout the community could be impacted if this is not handled correctly. We believe that the County also needs to do a much more thorough job of community outreach before undertaking a change like this, which will impact so many.

Please keep us informed on how your Board plans to proceed.
