What is Economic Development?

- Creation of wealth through which community benefits are created
- Three primary and inter-related approaches:
 - Business Attraction
 - Business Expansion
 - Business Retention
- Local government plays a key role

Benefits of Economic Development

- Economic development helps communities:
 - Increase Tax Base
 - Job Development, Retention and Attraction
 - Business Retention
 - Economic Diversification
 - Self-sufficiency
 - Productive Use of Property
 - Recognition of Local Products
 - Improved Quality of Life

History of Economic Development in El Dorado County

- Primarily Chambers of Commerce until late 1990's
- County included Economic Development Element in General Plan 1996
 - Officer at County level to coordinate and implement Economic Development programs
 - County hires first dedicated staff person in 1998
 - Identifies "Economic Development Services Provider Network" (now CEDAC)
 - Economic Development Element Principles

Economic Development Partners

- Economic development requires collaboration among many partners
 - County staff
 - Economic Development Division, other departments
 - Community & Economic Development Advisory Community (CEDAC)
 - Other organizations
