The committee is not normally in the position to review multiple applications and so we are in the position of having an embarrassment of riches. We are very pleased that there is such great interest in serving on the committee. With that said, we feel strongly that there is great work in front of us. As such it is critical that this appointment be made to the person who will be most valuable to the Cameron Park Community and Committee. The committee met with and discussed all three applicants and agree unanimously that Eva Robertson is the ideal candidate for the Cameron Park Design Review Committee.
