

RESOLUTION NO. 040-2015

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Participation in 340B Drug Pricing Program

WHEREAS, consistent with California Code of Regulations §1276, the County of El Dorado (County), through its Health and Human Services Agency, Public Health Division (HHSA), maintains and delivers community and clinical (Clinic) services that provide mandated public health intervention for communicable disease control including, but not limited to, tuberculosis, sexually transmitted, and vaccine preventable disease; and

WHEREAS, HHSA's Communicable Disease Unit investigates all reported or discovered communicable disease consistent with Title 17 California Code of Regulations §2500, §2593, §2641.5-2643.20, and §2800-2812 Reportable Diseases and Conditions to ensure needed diagnostic testing, proper pharmaceutical prophylaxis, treatment, or vaccination and additional containment measures as appropriate including isolation work or school exclusion; and

WHEREAS, pharmaceuticals are purchased for prophylaxis or treatment of individuals diagnosed with or exposed to communicable disease including but not limited to tuberculosis, rabies, measles, diphtheria, pertussis, etc.; and

WHEREAS, the Federal Government maintains a 340B Drug Pricing Program that the County, through the State of California, was a participant until Federal requirements changed in 2014, at which time the State discontinued its role as a the 340B Administrator for local government public health jurisdictions and deferred this responsibility to counties throughout California thereby resulting in the suspension of the County's 340B Federal participation authority; and

WHEREAS, in order for the County to re-establish HHSA as a covered entity and participate in the 340B Drug Pricing Program, a Participant Change Form must be completed by HHSA, executed by the County Board of Supervisors or its designee, and submitted to the Federal Department of Health and Human Services, Health Resources and Services Administration.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of the County of El Dorado hereby:

- 1) Authorizes HHSA to complete the 340B Participant Change Form; and
- 2) Delegate and authorizes the HHSA Director, or their designee, to execute, in the name of the County of El Dorado, the 340B Participant Change Form to reinstate the Clinic's 340B ID as well as any other future documents required to re-establish and maintain its enrollment in the 340B Drug Pricing Program or similar program, and submit same to the Federal Department of Health and Human Services, Health Resources and Services Administration or as otherwise directed by the 340B Administrator.
