I co-authored the community and economic development grant for the Divide Chamber of Commerce which was funded last year. We succeeded in our goal which was a welcome sign to El Dorado County in Cool. We were also able to utilize the funds for 4 more community welcome signs on the Divide. I helped again to write the second grant for 2015 which has been approved to further support tourism in North County, as well as the County as a whole. Additionally, I participated in the Regulatory Reform group for two years, working with both the Rural Lands and Ag sub-groups. I also provided input to the draft of the Home Occupation Ordinance which can be valuable to our county and our home based businesses.
