### AGREEMENT FOR SERVICES #277-S1311 AMENDMENT I

This Amendment I to that Agreement for Services #277-S1311 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and National Medical Services, Inc., a Pennsylvania Corporation, duly qualified to conduct business in the State of California, whose principle place of business 3701 Welsh Road, Willow Grove, PA 19090 and whose Agent for Service of Process is Incorp Services, Inc., 5716 Corsa Ave Ste 110, Westlake Village, CA 91362-7354; (hereinafter referred to as "Consultant");

**NOW, THEREFORE**, the parties hereby agree that Agreement for Services #277-S1311 shall be amended a first time as follows:

#### ARTICLE III

**Compensation for Services:** For services provided herein, County agrees to pay Consultant monthly in arrears and within thirty (30) days following the County's receipt and approval of itemized invoices(s) identifying services rendered. For the purpose of this Agreement, the billing rate shall be in accordance with Exhibit "A" to the original Agreement.

Said notice shall become part of this Agreement upon acknowledgment in writing by the County Contract Administrator, and no further amendment of the Agreement shall be necessary provided that such change of address does not conflict with any other provisions of this Agreement.

#### ARTICLE XXVII

Audit by California State Auditor: Consultant acknowledges that if total compensation under

this agreement is greater than \$10,000.00, this Agreement is subject to examination and audit by the California State Auditor for a period of three (3) years, or for any longer period required by law, after final payment under this Agreement, pursuant to California Government Code §8546.7. In order to facilitate these potential examinations and audits, Consultant shall maintain, for a period of at least three (3) years, or for any longer period required by law, after final payment under the contract, all books, records and documentation necessary to demonstrate performance under the Agreement.

#### ARTICLE XXVIII

**Taxes:** Consultant certifies that as of today's date, it is not in default on any unsecured property taxes or other taxes or fees owed by Consultant to County. Consultant agrees that it shall not default on any obligations to County during the term of this Agreement.
