# AGREEMENT FOR SERVICES #277-S1311 AMENDMENT I

This Amendment I to that Agreement for Services #277-S1311 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and National Medical Services, Inc., a Pennsylvania Corporation, duly qualified to conduct business in the State of California, whose principle place of business 3701 Welsh Road, Willow Grove, PA 19090 and whose Agent for Service of Process is Incorp Services, Inc., 5716 Corsa Ave Ste 110, Westlake Village, CA 91362-7354; (hereinafter referred to as "Consultant");

### RECITALS

**WHEREAS**, Consultant has been engaged by County under Agreement for Services #277-S1311 to provide forensic analysis and toxicology services on an "as requested" basis for the Sheriff's Office, Coroner Division, in accordance with Agreement for Services #277-S1311, dated February 5, 2013, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase compensation, hereby amending ARTICLE III -Compensation for Services; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE X – Notice to Parties; and

WHEREAS, the parties hereto have mutually agreed to add ARTICLE XXVI – Change of Address, ARTICLE XXVII – Audit by California State Auditor, and ARTICLE XXVIII - Taxes; and

**NOW, THEREFORE,** the parties hereby agree that Agreement for Services #277-S1311 shall be amended a first time as follows:

#### **ARTICLE III**

**Compensation for Services:** For services provided herein, County agrees to pay Consultant monthly in arrears and within thirty (30) days following the County's receipt and approval of itemized invoices(s) identifying services rendered. For the purpose of this Agreement, the billing rate shall be in accordance with Exhibit "A" to the original Agreement.

All invoices are to reference Agreement #277-S1311 and sent to:

El Dorado County Sheriff's Office Attention: Accounting Dept 300 Fair Lane Placerville, CA 95667 Total amount of this Agreement, as amended, shall not exceed \$150,000.00 for the two (2) year period.

### ARTICLE X

**Notice to Parties:** All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested.

#### ARTICLE XXVI

Change of Address: In the event of a change in address for Consultant's principal place of business, Consultant's Agent for Service of Process, or Notices to Consultant, Consultant shall notify County in writing pursuant to the provisions contained in this Agreement under the Article titled "Notice to Parties". Said notice shall become part of this Agreement upon acknowledgment in writing by the County Contract Administrator, and no further amendment of the Agreement shall be necessary provided that such change of address does not conflict with any other provisions of this Agreement.

#### ARTICLE XXVII

Audit by California State Auditor: Consultant acknowledges that if total compensation under

this agreement is greater than \$10,000.00, this Agreement is subject to examination and audit by the California State Auditor for a period of three (3) years, or for any longer period required by law, after final payment under this Agreement, pursuant to California Government Code §8546.7. In order to facilitate these potential examinations and audits, Consultant shall maintain, for a period of at least three (3) years, or for any longer period required by law, after final payment under the contract, all books, records and documentation necessary to demonstrate performance under the Agreement.

## ARTICLE XXVIII

Taxes: Consultant certifies that as of today's date, it is not in default on any unsecured property taxes or other taxes or fees owed by Consultant to County. Consultant agrees that it shall not default on any obligations to County during the term of this Agreement.

Except as herein amended, all other parts and sections of this Agreement for Services #277-S1311 shall remain unchanged and in full force and effect.
