Psychiatric Emergency Services (PES) (Jamie Samboceti and Sabrina Owen)

- PES continues to be busy on both slopes.
- SLT in the last 30 days: 34 crisis assessments, 17 hospitalized (1 open client), 2 referred to Substance Abuse Treatment.
- WS in the last 30 days: 92 crisis assessments, 29 hospitalized (2 open clients), 13 referred to Substance Abuse Treatment.

Crisis Intervention Teams (CIT) (Jamie Samboceti and Sabrina Owen)

- Good news- Sheriff's CIT Grant training delays have been resolved and CIT training will
 commence shortly for all First Responders. Sheriff, Police and Fire Department on both slopes
 to receive 8 hours of CIT training and a 4 hour training will be made available for interested
 County employees, NAMI and members of the general public.
- Both Jamie and Sabrina will be attending a California CIT event in June

Psychiatric Health Facility (Patricia Charles-Heathers)

- There were **35** Admissions in February, 2015; **12** Admissions were El Dorado County residents and **23** were Out of County residents.
- There were 24 El Dorado County residents discharged in March, 2015; 16 to home with support,
 5 to home without support,
 1 to MHRC,
 2 to Board and Care.
- Upon discharge, **19** El Dorado County residents were insured and **5** El Dorado County residents were pending insurance.
- During the month of February, there were 0 seclusion episodes, 0 restraint episodes and 1 medication error.

MHSA (Ren Scammon)

- The MHSA Plan Update is being drafted and should be posted soon. The Public Hearing will be scheduled at the end of the 30-day comment period on the Draft Plan Update.
- Trailside Terrace in Shingle Springs has two vacant apartments. An application is in process for the three-bedroom vacancy and the waiting list is under review to determine the next eligible applicant for the one-bedroom vacancy.

Behavioral Health Court (Shirley White)

- Placerville Behavioral Health Court has 12 active participants; 1 participant successfully completed a residential treatment stay. 1 new referral pending assessments.
- South Lake Tahoe Behavioral Health Court has 2 active participants; 1 client is in residential treatment and upon completion of treatment will be accepted into the program..

AB 109 (Shirley White)

A total of 6 AB 109 clients are receiving Residential Substance Abuse Treatment. These clients are being given additional support to create transitional plans to ensure that they are successful when they return to CCC services. 7 AB109 clients are receiving Transitional Housing services. A total of 39 clients are receiving Mental Health and Substance Use Disorder services at the Community Corrections Center. South Lake Tahoe is serving 7 clients in the Moral Reconation Therapy group in the jail and 4 clients are receiving outpatient Substance Use Disorder treatment at Tahoe Turning Point. 1 participant successfully completed Moral Reconation Therapy this month.

Patients' Rights Advocate (Doris Jones)

- Mental Health Division Grievances to date for FY 14/15; 8 grievances have been received, 8
 have been completed. There are 0 outstanding grievances to be assigned for investigation and 0
 outcomes pending.
- Ongoing Client Advocacy with Telecare Psychiatric Health Facility, Mental Health, Public Guardian, other County Departments and community-based organizations regarding Mental Health client needs, requests, issues and rights.
- Telecare Psychiatric Health Facility weekdays on site to provide advocacy, support, information, and education to Mental Health clients, client's family and support system members and agency staff; attend care team meetings, staffings and represent clients at Certification Review Hearings.
- Ongoing advocacy for the implementation of policies and procedures that coincide with applicable codes, regulations, laws and mental health patients' rights.
- Ongoing resources, information, education, consultation and training materials provided for Health and Human Services and Telecare staff.
- Mental Health Sites Safety Coordination with all Mental Health facility sites regarding safety issues and to ensure quarterly fire drills are scheduled, held and documented and periodic facility safety inspections occur per County guidelines.
- County-Wide Safety Coordinator: Attend quarterly meetings, participate in projects, complete all required follow-up, provide updates and information to Mental Health Site Safety Team Members.
