

RESOLUTION NO. 069-2015

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Restrict Usage of Rubicon Trail Roads for the 63rd through the 67th Annual "Jeepers Jamboree" and the 37th through 41st Annual "Jeep Jamboree"

WHEREAS "Jeepers Jamboree", Inc. (sponsor) desires to hold a Four-Wheel Drive Event for the next 5 years that will last 5 consecutive days, Wednesday through Sunday, and will occur on July 22-July 26, 2015, July 27-July 31, 2016, July 26-July 30, 2017, July 25-July 29, 2018, July 24-July 28, 2019 and the "Jeep Jamboree" Inc. (sponsor) desires to hold a Four-Wheel Drive event for the next 5 years that will last 4 consecutive days, Thursday through Sunday, and will occur on July 30-August 2, 2015, August 4-August 7, 2016, August 3-August 6, 2017, August 2-August 5, 2018, August 1-August 4, 2019, on the Rubicon Trail in El Dorado County; and

WHEREAS Jeepers Jamboree provides economic benefits to Georgetown and El Dorado County, and;

WHEREAS Jeepers Jamboree is an historic event on the Rubicon Trail, and important to El Dorado County, and;

WHEREAS said sponsor has applied for a parade permit pursuant to Vehicle Code 21102(e), Ordinance Code §12.37.010 et seq., and County Resolution 110-79, in order to restrict usage of the Rubicon Trail during these two parade events to participants only; and

WHEREAS the number of vehicles and users anticipated in each parade event, and the unusual circumstances of the Rubicon Trail, require that the Jamboree participants be allowed to pass through on the Rubicon Trail in an organized, continuous and uninterrupted group, for the safety and protection of Jamboree participants and other users, and;

WHEREAS the Jeepers Jamboree and Jeep Jamboree are historic events and have had exclusive use of the Rubicon Trail, these events are hereby "Grandfathered in" and there will be no other parade permits issued on the Rubicon Trail, and;

WHEREAS Jeep Jamboree, Inc. and El Dorado County agrees that this permit can be revokes or modified anytime within the five year time period by the Board of Supervisors;

NOW THEREFORE BE IT RESOLVED that the parade permit be issued for portions of the Rubicon Trail from the Wentworth Springs Campground and Loon Lake at Gerle Creek eastward to the Placer County Line, for the 63rd – 67th Annual "Jeepers Jamboree" only, from 6:00 a.m. to 10:00 p.m., starting on Wednesday, through Friday, Saturday and Sunday from Ellis Creek to the Placer County Line, July 22-July 26, 2015, July 27-July 31, 2016, July 26-July 30, 2017, July 25-July 29, 2018, July 24-July 28, 2019; and for the 37th - 41st Annual "Jeep Jamboree," from 6:00 a.m. to 10:00 p.m. daily, starting Thursday and Friday from the Wentworth Spring Campground and Loon Lake at Gerle Creek eastward to the Placer County Line, Saturday and Sunday from Buck Island to the Placer County Line . Starting on July 30-August 2, 2015, August 4-August 7, 2016, August 3-August 6, 2017, August 2-August 5, 2018, August 1-August 4, 2019, subject to the conditions set forth in Resolution No. 110-79 and in the "Application for Road Closure" submitted by the applicant.

This resolution and the application with conditions shall together constitute the parade permit.
