**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS**, a public hearing was held on June 11, 2013 for the purpose of adjusting solid waste collection rates in Franchise Area #6, which generally refers to the southwestern portion of the County, by 2% increase;
