RESOLUTION NO. 059-2014

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, a public hearing was held on June 10, 2014 for the purpose of adjusting solid waste collection rates in Franchise Area #6, which generally refers to the southwestern portion of the County, by 1.6% increase;
