Ms. Lane:

Please be advised that the Office of the County Counsel is aware that the Recorder-Clerks Office has repeatedly informed you that the records in response to your March 31, 2015, Public Records Act (PRA) request (for the "Roster of Public Agencies") are available for inspection at no charge, or copies of these records may be obtained when the County receives payment of costs for copying at the statutorily approved rate of \$ 50 (fifty cents) per page. See Gov. Code section 26831 authorizing recorders to charge for publicly recorded documents. As you have been told, there are approximately 400 pages of records for you to inspect, or to have copies made.

The Recorder-Clerk routinely confers with County Counsel on legal issues, including those involving requests for Public Records. Contrary to your assertions, that County staff is "incompetent" or that the "County has something to hide", the Recorder-Clerk has fully complied with all requirements of the PRA when you were timely provided the opportunity to inspect and receive copies of all documents that you requested. Your disparaging comments maligning the County and staff do not change the fact that you and the County can also respectfully disagree about the requirements of the law under the PRA.

It is the County's position that the responses you have received from the Recorder-Clerk's office are in full compliance with both the letter and the spirit of the law. The records you seek have been made available for inspection and copying in a timely manner. There are no legal requirements to create or provide you with electronic records when they do not exist. The PRA requires agencies to provide the documents in the format in which they are kept. While we understand that you would like a PDF file at no charge, there is no legal requirement to do so. Please see Gov. Code sections 6253.9 (1) and (c) that state in part,

"The agency shall make the information available in any electronic format in which it holds the information." and "Nothing in this section shall be construed to

require the public agency to reconstruct a record in an electronic format if the agency no longer has the record available in an electronic format." (emphasis added)

Here, the documents have <u>never</u> been maintained as electronic documents. The County is not obligated to create new documents or formats for you. To do so would be unduly burdensome.

You state that I and Senior Deputy County Counsel Paula Frantz told you that records are available to you in an electronic format and that copies of records will be provided to you without charge. This is a misstatement. If the documents were <u>kept</u> in an electronic format, you would ordinarily be entitled to the documents electronically (this is subject to some exceptions, see Gov. Code section 6253.9) and would, therefore, not be required to pay copying costs (although you might be subject to other costs of providing the documents). Similarly, your statement of what you were told my Mr. Mitrisin, Clerk of the Board of Supervisors, appears to be a misunderstanding of what you were told. While Mr. Mitrisin has previously made PDFs of Clerk of the Board, he has <u>not</u> agreed to take documents that are maintained at the clectronic format, in PDF or any other format, for you. Again, nothing in the PRA or elsewhere in the law mandates that the county create new documents for you in formats other than those ordinarily maintained.

> To conclude, the records you requested are <u>immediately available for inspection at no charge</u> during regular business hours at the Clerk Recorders Office located at 360 Fair Lane. Alternatively, we would be happy to provide paper copies upon payment of applicable statutory costs for copying.
