Dear Gerri,

I write as a follow-up to our telephone conversation, from yesterday, as regards collection rates for the garbage services we provide to the franchised Tahoe West Shore area of El Dorado County. We hereby opt to reduce our original request, dated 3/12/13, in consideration of the garbage collection rate levels that currently allow us to make a sustainable return on investment in the service area and as a gesture of goodwill as we enter into contract extension negotiations this summer (recognizing the El Dorado Board of Supervisors direction to staff as outlined in Agenda item 12-0508, dated 5/8/2012). Please find the attached worksheet detailing our revised comprehensive rate sheet reflecting a requested 1% increase to garbage collection rates, effective July 1st 2013, instead of the originally requested 5% adjustment allowed for under the contract terms.

As in prior years, our gesture in extending the rate adjustment concession to El Dorado County garbage collection customers is meant solely for the upcoming '13-'14 rate year and is not intended to set precedent or in any way modify the rate adjustments allowed for under the existing contract terms in subsequent years.

Also attached is a copy of the notification postcard that we intend to send to customers affected by the rate adjustment. Upon your review and approval, we plan to move forward with mailing the postcards before close of business on Tuesday, May 21st.

Thank you for all that we have accomplished together over the recent years and for your commitment to the strong working relationship between El Dorado County and our company. We remain committed to providing excellent service to our El Dorado customers with our administrative offices immediately adjacent and our company operations nearby. We look forward to our upcoming discussions on extending our relationship into future years.

We also look forward to seeing you at the rate hearing on June 11th. David Achiro will likely represent our company. Recognizing the travel distance during our busiest season, we have been very appreciative of the County's past efforts to schedule our agenda items before the lunch break. While we know you don't have full control over the agenda item scheduling, we would again be deeply appreciative of any effort to complete the agenda item(s) requiring our company's presence as early in the day as possible.
