

**AGREEMENT FOR SERVICES 178-S1311  
AMENDMENT I**

**THIS AMENDMENT I** to that Agreement for Services 178-S1311, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as “County”) and Remi Vista, Inc., a California corporation duly qualified to conduct business in the State of California, whose principle place of business is 393 Park Marina Circle, Redding, CA 96001 (hereinafter referred to as “Contractor”) and whose Agent for Service of Process is John W. Tillery, 4636 Columbine Drive, Redding, CA 96002.

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide twenty-four (24) hour residential mental health services for County-authorized minors with serious emotional problems (hereinafter referred to as “Client” or “Clients”), in accordance with Agreement for Services 178-S1311, dated November 6, 2012, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to extend the term of the original Agreement, thereby amending **Article II - Term**, increase the maximum obligation of the Agreement, thereby amending **Article III - Compensation for Services**, to update **Article IV – Cost Report**, and to update **Article XXV – Notice to Parties** and **Article XXXVIII – Administrator**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services 178-S1311 shall be amended a first time as follows:

1) Article II shall be amended in its entirety to read as follows:

**ARTICLE II**

**Term:** This Agreement shall be effective July 1, 2012 and shall expire June 30, 2015, unless terminated earlier pursuant to provisions under the Articles titled “Fiscal Considerations” or “Default, Termination, and Cancellation.”

2) Article III shall be amended in its entirety to read as follows:

**ARTICLE III**

**Compensation for Services:** Contractor shall submit monthly invoices no later than thirty (30) days following the end of a “service month” except in those instances where Contractor obtains written approval from County Health and Human Services Agency Director or Director’s designee granting an extension of the time to complete billing for services or expenses. For billing purposes, a “service month” shall be defined as a calendar month during which Contractor provides services in accordance with the Article titled “Scope of Services.”

For services provided herein, County agrees to pay Contractor monthly in arrears and within forty-five (45) days following the County's receipt and approval of itemized invoice(s) identifying services rendered.

C. The maximum obligation for services provided during the term of this Agreement shall be as follows:

<b>Total Not-to-Exceed of Agreement</b>	<b>\$300,000</b>

Contractor's allowable services billed to County may vary by up to ten percent (10%) between fiscal year amounts shown above, provided any such variation does not change the total Not-to-Exceed amount of this Agreement.

3) Article IV shall be amended in its entirety to read as follows:

**ARTICLE IV**

**Cost Report:** Contractor shall submit an annual Cost Report to County on or before October 31st of each year for the preceding fiscal period of July 1<sup>st</sup> through June 30<sup>th</sup> ("fiscal period"). Contractor shall prepare the Cost Report in accordance with the State Department of Health Care Services Cost and Financial Reporting System Local Program Financial Support Instruction Manual, incorporated by reference as if fully set forth herein.

The Cost Report shall be the final financial record of services rendered under this Agreement, for subsequent audits, if any. Such reported costs and allocations shall be supported by source documentation maintained by Contractor and available at any time to Contract Administrator upon reasonable notice.

It is agreed between County and Contractor that the rates stated in this Agreement are intended to approximate the Contractor's actual costs. Should the actual rate as determined in the Cost Report for the fiscal period be less than the rate(s) identified herein, Contractor agrees to reimburse County for all amounts paid in excess of the actual rate. Reimbursement shall be remitted to County no later than December 31<sup>st</sup> following the fiscal period. Based upon written approval by the Health and Human Services Agency Director, this reimbursement may be made via monthly installment payments for up to six (6) months.

4) Article XXV shall be amended in its entirety to read as follows:

**ARTICLE XXV**

**Notice to Parties:** All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be addressed as follows:

Change of Address: In the event of a change in address for Contractor’s principal place of business, Contractor’s Agent for Service of Process, or Notices to Contractor, Contractor shall notify County in writing as provided in the article titled “Notice to Parties.” Said notice shall become part of this Agreement upon acknowledgment in writing by the County Contract Administrator, and no further amendment of the Agreement shall be necessary provided that such change of address does not conflict with any other provisions of this Agreement.


5) Article XXXVIII shall be amended in its entirety to read as follows:

**Article XXXVIII**

**Administrator:** The County Officer or employee with responsibility for administering this Agreement is Laura Walny, Program Manager II, Health and Human Services Agency, or successor.

Except as herein amended, all other parts and sections of that Agreement 178-S1311 shall remain unchanged and in full force and effect.
