# AGREEMENT FOR SERVICES 131-S1311 AMENDMENT I

This Amendment I to that Agreement for Services 131-S1311, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Summitview Child & Family Services, Inc., a California non-profit public benefit corporation qualified as a tax exempt organization under Title 26 Code of Federal Regulations, Section 1.501 (c) (3) commonly referred to as Section 501 (c) (3) of the Internal Revenue Code of 1986, whose principal place of business is 768 Pleasant Valley Road, #304, Diamond Springs, CA 95619 (hereinafter referred to as "Contractor"), and whose Agent for Service of Process is Anna Gleason, 768 Pleasant Valley Road, #304, Diamond Springs, CA 95619.

#### RECITALS

WHEREAS, Contractor has been engaged by County to provide 24-hour residential services for County-authorized minors with serious emotional problems (hereinafter referred to as "Clients") on an "as requested" basis for the County of El Dorado Health and Human Services Agency, Mental Health Division, in accordance with Agreement for Services 131-S1311, dated September 11, 2012, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement, thereby amending Article II - Term, increase the not-to-exceed amount of the original Agreement, thereby amending Article III - Compensation for Services, update Cost Report language, thereby amending Article IV - Cost Report, and update Article XXIV - Notice to Parties;

NOW THEREFORE, the parties do hereby agree that Agreement for Services 131-S1311 shall be amended a first time as follows:

1) Article II shall be amended in its entirety to read as follows:

#### **ARTICLE II**

**Term:** This Agreement shall cover the period of July 1, 2012 through June 30, 2015 unless earlier terminated pursuant to the provisions under the Article titled "Fiscal Considerations" and "Default, Termination, and Cancellation" herein.

2) Article III shall be amended in its entirety to read as follows:

#### **ARTICLE III**

Compensation for Services: Contractor shall submit monthly invoices no later than thirty (30) days following the end of a "service month" except in those instances where Contractor obtains written approval from County Health and Human Services Agency Director or Director's designee granting an extension of the time to complete billing for services or expenses. For billing purposes, a "service

month" shall be defined as a calendar month during which Contractor provides services in accordance with the Article titled "Scope of Services."

For services provided herein, County agrees to pay Contractor monthly in arrears and within forty-five (45) days following the County's receipt and approval of itemized invoice(s) identifying services rendered.

- C. Rehabilitation Expenses: All purchases of goods and services for Rehabilitation Clients up to \$500 must be approved in writing by the HHSA Director or designee. Purchases over \$500 must be approved in wiring by the HHSA Director or Assistant Director of Health Services. Rehabilitation expenses must be shown separately on invoices and Contractor must provide supporting documentation in the form of original, itemized receipts.
- D. The maximum obligation for services provided during the term of this Agreement shall be as follows:

Contractor's allowable services billed to County may vary by up to ten percent (10%) between fiscal year amounts shown above, provided any such variation does not change the total Not-to-Exceed amount of this Agreement.

# 3) Article IV shall be amended in its entirety to read as follows:

#### ARTICLE IV

Cost Report: Contractor shall submit an annual Cost Report to County on or before October 31st of each year for the preceding fiscal period of July 1<sup>st</sup> through June 30<sup>th</sup> ("fiscal period"). Contractor shall prepare the Cost Report in accordance with the State Department of Health Care Services Cost and Financial Reporting System Local Program Financial Support Instruction Manual, incorporated by reference as if fully set forth herein.

The Cost Report shall be the final financial record of services rendered under this Agreement, for subsequent audits, if any. Such reported costs and allocations shall be supported by source documentation maintained by Contractor and available at any time to Contract Administrator upon reasonable notice.

It is agreed between County and Contractor that the rates stated in this Agreement are intended to approximate the Contractor's actual costs. Should the actual rate as determined in the Cost Report for the fiscal period be less than the rate(s) identified herein, Contractor agrees to reimburse County for all amounts paid in excess of the actual rate. Reimbursement shall be remitted to County no later than December 31<sup>st</sup> following the fiscal period. Based upon written approval by the Health and Human Services Agency Director, this reimbursement may be made via monthly installment payments for up to six (6) months.

# 4) Article XXIV shall be amended in its entirety to read as follows:

#### ARTICLE XXIV

**Notice to Parties:** All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to County shall be addressed as follows:
