#### FIRST AMENDMENT TO AGREEMENT FOR SERVICES #640-S1411

THIS FIRST AMENDMENT to that Agreement for Services #640-S1411 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), acting by and through County Service Area Number 10, a lawfully established County Service Area as defined by Government Code Section 25210 et seq., and Tetra Tech BAS, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 1360 Valley Vista Drive, Diamond Bar, California 91765, (hereinafter referred to as "Consultant");

#### RECITALS

WHEREAS, Consultant has been engaged by County to provide solid waste, landfill and wastewater treatment plant general engineering support for the Community Development Agency pursuant to Agreement for Services #640-S1411, dated August 12, 2014, incorporated herein and made by reference a part hereof (hereafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$200,000, amending ARTICLE III, Compensation for Services;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #640-S1411, as follows:

ARTICLE III, Compensation for Services, paragraph G. of the original Agreement is amended in its entirety to read as follows:

The total amount of this Agreement, including all of the services detailed in Exhibit A, Scope of Work, and inclusive of all work of subconsultatnts, costs, expenses, and Task Orders and Work Order shall not exceed \$500,000.

Except as herein amended, all other parts and sections of Agreement for Services #640-S1411 shall remain unchanged and in full force and effect.
