Mr. Plimpton, et al,

Thank you so much for perfectly demonstrating the bully tactics that made it necessary for me to involve the Sheriff in RMAC (aka River Mafia Politics.)

As for the noise complaint you referred to. I recall that several neighbors who lived in the vicinity of Beach Court complained about all the noise coming from the SNH, Marco's Café and Point Pleasant all at the same time. One of them filed a complaint with the Sheriff when she was threatened by a guy at one of the RMAC meetings so she referred my name to be interviewed. I shared with the deputy how I was accosted by a druggie at the ARR when I drove down there after midnight to complain to the campground manager, only there was no one on duty.

That's been the modus operandi that has created the problem in the first place. As a result the Community Clamor Committee was created for the purpose of avoiding direct confrontations and potentially dangerous situations.

I believe this would be a perfect opportunity for Vickie Sanders to ensure the matter of code/law... enforcement is made on the next RMAC agenda, with an emphasis on bully tactics and libel.

Codes, laws and ordinances are meant to be enforced and ensure the quality of life that most of us moved up here to enjoy in the first place. That is the purpose of the River Management Plan and the recent RMAC workshop that consultant Steve Peterson conducted at Grange Hall. We're all anxious to see how he presents the issues discussed at those meetings.

Every resident is entitled to enjoy their private property in peace and safety, free from harassment, unwanted intrusions, and hate mongering. Although I have some wonderful friends and neighbors, Coloma has some very unique issues that make life less than idvllic. Laurel Brent-Bumb described it awhile back to the BOS as "the environmental belly of the beast."

Last month the people who built my home came for a visit. The first question they asked had to do with the intrusive and unreasonable noise from amplified events at the Coloma Resort. It had been a problem for them as it has for many of the residents who've signed petitions concerning the abuse of C of C businesses who believe they are above the law. The Coloma Resort was the only one that refused to participate or comply. By the tenor of your emails, the Community Clamor Committee (CCC) appears to have devolved into something more like the KKK.

My parents taught me to stand up to bullies, so I wouldn't dream of selling my home to move elsewhere as you, Mr. Hayden, and a few others suggested. I intend to bloom exactly where the good Lord planted me, hence my active involvement in matters concerning safety and the quality of life here in God's Country.

My parents also taught me not to judge people without getting to know them. How they treat you will be a good indicator of their character and integrity. Although I stayed at Point Pleasant 20+ years ago, I've never met you or seen you participate in any of the meetings that I attend regularly. By the

disrespect you and others have demonstrated for me and this forum, I wouldn't think of referring any business to you. Bullying is bad business.

As for Mike Bean's delegation to his minions, you've done a great job of "ruining" CLNews: I am on vacation with limited email access. I don't have time for this drama now. Please try to ruin CLNews while I am away.

I guess Mike was too close to the issues and inconvenient truth in an email exchange that included a photo of a recognizable trespasser within my property boundaries.

Sheriff John D'Agostini wants to remind everyone that fireworks of any kind are illegal in El Dorado County. Any person caught possessing, transporting, purchasing, selling or even storing fireworks could be cited or arrested and booked into the El Dorado County Jail for violating the misdemeanor county ordinance.

Illegal fireworks in El Dorado County even include sparklers or those sold in Sacramento County as "Safe and Sane." All fireworks will be confiscated as evidence, rendered safe and properly disposed of. Thousands of people, most often children and teens, are injured while using consumer fireworks every 4th of July, according to the National Fire Protection Association. Despite the danger, few people understand or respect the associated risks such as devastating burns, severe injuries to eyes, ears and extremities, structure fires, wildland fires and even death. Yet many who use illegal fireworks do so without fear of repercussions or consequences.

Have a fun and safe holiday weekend in El Dorado County, without the fear of fire or injury. Pyrotechnics can be enjoyed by the whole family at several venues over the weekend. Events are planned at the El Dorado County Fairgrounds, South Lake Tahoe and El Dorado Hills Town Center.

Make your celebration a safe one without endangering yourselves or your neighbors. With dry conditions due to heat and the drought, safety should be paramount for everyone.

If you see others using fireworks, report it to law enforcement immediately. You may be saving someone's life, home, neighborhood or forest lands.

Overview

Cyberstalking. Cyberstalking is the use of the Internet, email or other electronic communications to stalk, and generally refers to a pattern of threatening or malicious behaviors. Cyberstalking may be considered the most dangerous of the three types of Internet harassment, based on a posing credible threat of harm. Sanctions range from misdemeanors to felonies.

Cyberharassment. Cyberharassment differs from cyberstalking in that it may generally be defined as not involving a credible threat. Cyberharassment usually pertains to threatening or harassing email messages, instant messages, or to blog entries or websites dedicated solely to tormenting an individual. Some states approach cyberharrassment by including language addressing electronic communications in general harassment statutes, while others have created stand-alone cyberharassment statutes.
