



## RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**RESOLUTION AUTHORIZING A SECOND AMENDMENT TO THE  
SOLID WASTE SERVICES FRANCHISE AGREEMENT BETWEEN THE COUNTY  
OF EL DORADO AND WASTE CONNECTIONS OF CALIFORNIA, INC.,  
DBA EL DORADO DISPOSAL SERVICE**

**WHEREAS**, the Legislature of the State of California, by enactment of the California Integrated Waste Management Act of 1989 (AB 939), has declared that it is within the public interest to authorize and require local agencies to make adequate provision for solid waste handling within their jurisdictions; and

**WHEREAS**, effective October 21, 2014, the County entered into a Franchise Agreement with Waste Connections of California, Inc. dba El Dorado Disposal ("El Dorado Disposal") which, among other things, granted the exclusive right and obligation, subject to certain limitations and renewal options, until October 20, 2029, to collect, transport, process, recycle, and dispose of municipal solid waste generated by residential, commercial, and industrial customers in a delineated franchise area on the west slope of the County, defined in Exhibit A to the El Dorado Disposal Franchise Agreement ("EDD Franchise Agreement"), and to operate the Material Recovery Facility; and

**WHEREAS**, effective December 2, 2014, the County entered into a Franchise Agreement with South Tahoe Refuse Co., dba Sierra Disposal Service ("Sierra Disposal Service") which, among other things, granted the exclusive right and obligation, subject to certain limitations and renewal options, until December 1, 2024, to collect, transport, process, recycle, and dispose of municipal solid waste generated by residential, commercial, and industrial customers in a delineated franchise area on the west slope of the County defined in Exhibit A to the Sierra Disposal Service Franchise Agreement ("SDS Franchise Agreement"); and

**WHEREAS**, the SDS Franchise Agreement cannot be transferred or assigned without prior written consent of the County; and

**WHEREAS**, Sierra Disposal Service has requested that the County consent to the assignment of the SDS Franchise Agreement to El Dorado Disposal; and

**WHEREAS**, El Dorado Disposal has requested that the services being provided by Sierra Disposal Service under the SDS Franchise Agreement be consolidated into EDD Franchise Agreement dated October 21, 2014; and

**WHEREAS**, the SDS Franchise Area will now be known as "Area C" of the EDD Franchise Agreement and "Area A" and "Area B" shall consist of all other areas within the EDD Franchise Agreement; and

**WHEREAS**, the County's consent to the assignment of the SDS Franchise Agreement to

El Dorado Disposal is made with the understanding that the payment of the purchase price by El Dorado Disposal for the acquisition of the assets of Sierra Disposal Service shall not result in an increase in solid waste collection and/or processing or disposal rates of County residents and businesses to be served by El Dorado Disposal solely as a result of such acquisition, compared with what these rates would have been if no such acquisition had occurred; and

**WHEREAS**, pursuant to Section 13 of the SDS Franchise Agreement the County is entitled to recover its costs associated with the assignment of the SDS Franchise Agreement to El Dorado Disposal in an amount not to exceed \$35,000.

**NOW, THEREFORE**, be it resolved, that the Board of Supervisors of the County of El Dorado hereby:

1. Consents to the assignment of the Sierra Disposal Franchise Agreement by South Tahoe Refuse Co., dba Sierra Disposal Service, to Waste Connections of California, Inc., dba El Dorado Disposal Service, subject to the terms and conditions of the attached Second Amendment to the El Dorado Disposal Franchise Agreement.
2. Approves consolidation and merger of the Sierra Disposal Service franchise area and the Sierra Disposal Service rate schedule approved by the Board of Supervisors in Resolution 186-2013, attached hereto as Exhibit A, into the El Dorado Disposal Franchise Agreement.
3. Approves the Second Amendment to the El Dorado Disposal Franchise Agreement, thereby terminating the Sierra Disposal Franchise Agreement, and authorizes the chairman of the Board to execute the Second Amendment on behalf of the County.
4. Establishes the franchise transfer fee in an amount not to exceed \$35,000 for the costs and expenses incurred by County associated with the assignment of the Sierra Disposal Service Franchise Agreement to El Dorado Disposal.


