## EL DORADO DISPOSAL RATES

#### Background/Benefits

- Proposed rates included in new EDD Franchise Agreement approved by the Board on October 21, 2014. Rates to be effective July 1, 2015.
- Contractor provided cart sizes of 35 (new), 64, or 96-gallons.
- Over 15,000 new carts distributed.
- Rate decrease for over 50% of residential customers.
- Multiple new vouchers for free services.
- Additional cleanup events.
- Unlimited green waste collection events.
- Construction of a new modern Material Recovery Facility (MRF) at no cost to the rate payer (estimated \$8 to \$12 million).
- New benefits will increase diversion.

- 2) Authorize the Chair to sign the Second Amendment to the El Dorado Disposal Service Franchise Agreement incorporating the Sierra Disposal Service franchise area (designated as Area C).
