- A scientifically-validated survey of Meyers area residents;
- Discussions in 'plain English' so everyone can discuss ideas without needing a degree in Environmental Policy;
- A clear discussion of the zoning and district boundary changes with the community and business owners,
  and
- A Meyers Advisory Council that is formed prior to the update of the Meyers Area Plan so we will have better representation - through a group subject to open meeting laws - in developing the new Area Plan – rather than after a new Plan is adopted.
