Discussion:

In general, we support the Tentative Map approval of **SERRANO VILLAGE C-2**. However, as discussed with you, the Developer and the Engineer, all utilities (sewer lines, water lines, recycled water lines, storm drain lines, etc.) should be right-sized to meet future needs of the adjacent area. Therefore right-sizing should be made a condition of the **TENTATIVE MAP**.

Specifically, the statement on the Map that: "Sewer line may be upsized in the future due to Bass Lake Hills connection" should be replaced by: "All utilities (sewer lines, water lines, recycled water lines, storm drain lines, etc.) shall be right-sized to accommodate future needs of Bass Lake Hills connections, subject to an equitable reimbursement schedule developed by EI Dorado County for upsizing costs involved".
