After discussions with County Counsel, Roger and Peter we are recommending the motion be revised for tomorrow (Item 29 - Legistar 11-0356). Below is the recommended motion and attachment A as referenced in the motion.

Motion:

Supervisor Sweeney and Supervisor Knight recommend the Board forward Attachment A, *Proposed Targeted General Plan Amendment Items*, to the Planning Commission for discussion and recommendation of specific amendments to be included in the final Resolution of Intention to amend the General Plan. The Board shall also confirm the following timeline for Staff and EDAC on next steps as presented on July 25, 2011:

- I. Planning Commission Workshop on Proposed General Plan Amendments and Zoning Ordinance Update - September 8, 2011
- II. Board of Supervisors CEQA Workshop - September 26, 2011
- III. Public Hearing to adopt Comprehensive Resolution of Intention, including previous Resolutions of Intention regarding General Plan Amendments and Zoning Ordinance update, Draft Project Description and Draft RFP for EIR - October-November (Date to be determined at September 26, 2011 BOS Workshop)

The motion from July 25th is what directs the preparation of a "Comprehensive Resolution of Intention, including previous Resolutions of Intention regarding General Plan Amendments and Zoning Ordinance update"...but we do not believe we are ready for this just yet. Some additional work on specifics for General Plan Amendments is needed and can be discussed at the Planning Commission workshop in September.
