This Amendment IV to that Agreement for Services #356-S1011, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Alliant Insurance Services, Inc., a Delaware Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 100 Pine Street, 11<sup>th</sup> Floor, San Francisco, CA 94111; (hereinafter referred to as "Consultant");

**RECITALS**

**WHEREAS**, Consultant has been engaged by County to provide employee benefit consulting services for the Human Resources Department, in accordance with Agreement for Services #356-S1011, dated February 8, 2010, Amendment I dated November 27, 2012, Amendment II dated February 20, 2014, and Amendment III dated January 27, 2015, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to extend the term of the Agreement through January 31, 2017, hereby amending **ARTICLE II – Term** and **ARTICLE III – Compensation for Services**; and

**WHEREAS**, the parties hereto have mutually agreed to amend **ARTICLE XI – Notices to Parties** and **ARTICLE XX – Administrator**; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #356-S1011 shall be amended a fourth time as follows:

**ARTICLE II**

**Term:** The term of this Agreement, as amended, shall be for the period of February 1, 2010 through January 31, 2017.

**ARTICLE III**

**Compensation for Services:** is amended to increase the total amount of the Agreement by \$100,000.00 for a total not to exceed amount of \$710,000.00, inclusive of all costs and expenses.

**ARTICLE XI**
