My core values, past and current practice, and educational leadership vision for El Dorado County aligns to the goal of the Commission, "To serve as a voice and advocate for young children by developing initiatives that meet the best interests of children zero through five years and their communities." As an educational leader, I seek to lead and practice in a manner that integrates research, is collaborative, transparent, and outcome based for all children in El Dorado County.

- As the Principal and instructional leader of a high school “turn-around” effort, facilitated a rise in Sacramento Charter High School’s API from 568 to 786, a similar school ranking from 2 to 10, and a four-year college acceptance rate from 25% to 75%. - As the Director of Strategic Partnerships, recruited and led a team of business and community leaders to raise \$298,500, with an overall attendance of 1,000+ participants at the 2013 St. HOPE Dinner
