On September 15~16, 2012 American River Music, Inc. (ARM) is hosting the American River Music Festival at the Henningsen-Lotus County Park and three sponsoring campgrounds. ARM anticipates 1000 shuttle users (ticket buyers, volunteers, musicians, KVMR broadcast crew, vendors and festival staff) staying at Camp Lotus, American River Resort, and EarthTrek. ARM plans and prepares for up to 500 cars arriving to the campgrounds on Friday the 14th and departing on Sunday the 16th.

The project is for ARM to provide bus/van shuttles from the campgrounds (Camp Lotus, American River Resort, and EarthTrek) to the main stage (Henningsen-Lotus Park) and back during the festival's main stage hours of operation. The main stage hours of operation are Saturday and Sunday, September 15-16 from 9:30 A.M.-7:00 P.M. ARM's objective is to allow campers to leave their cars parked at their campground for the duration of the festival instead of having them drive from their campground to the park and back for the two days of main stage events. The driving distance between Camp Lotus and Henningsen-Lotus Park is 1.5 miles. The driving distance between American River Resort and Henningsen-Lotus Park is 2 miles, and the driving distance between EarthTrek and Henningsen-Lotus Park is 1 mile.

The Project Emissions Benefits/Cost Effectiveness calculations for Vanpool and Shuttle Evaluations are described as:

-Effectiveness Period=1 year

-Days (D) = 2

-Daily ridership (R), R=2500 and is based upon 750 campers riding once to the main stage and once back to their campground, and 250 campers riding twice to the main stage and twice back to their campground (based upon 2011 ridership).

-Annual Van/Shuttle VMT (Van VMT) =450 and is based on the distance of each shuttle loop and the number of projected loops done from each campground.

-For calculating Annual Emission Reductions the factors for ROG, NOx and PM10 Table 3A Average Auto Emission, March 2010, Analysis Period=1 Year, 2010, and Table 7 Medium Duty Vehicle Emission Factors (Low Emissions, Weight 10,001-14,000), March 2010 are used.

-All other numbers are default numbers (as advised by past AQMD staff), and calculations are done based upon the publication of the California Air Resources Board **Methods to find the Cost Effectiveness of Funding Air Quality Projects-May 2005.**

Due to the limited access to Henningsen-Lotus Park and the area's road situation ARM anticipates high auto idling times, very slow auto driving speeds and traffic congestion without the use of the shuttles.

The scope of work of the project is for both Saturday and Sunday ARM to contract with Coloma-Lotus based South Fork professional rafting outfitters for five 47-passenger buses and three 15-passenger vans from 9:30 A.M. to 7:00 P.M. to shuttle campers from their campgrounds to the main stage and back. All campgrounds and the main stage have posted shuttle schedules.

The budget, of 6,500 is based upon contracting with Coloma-Lotus based Whitewater Outfitter's providing the buses and vans. This project has dramatically lower costs versus charter bus companies (bids > 1,500/bus/day were received) due to all buses located within 1 mile of the shuttle locations and lower average daily rental estimates. The Outfitters have kept their quotes low to support the continued operation of the festival project.

Project Organization/Background

American River Music, Inc. (ARM), based in Lotus, was formed in 2007 as a nonprofit California Corporation with a mission "to teach, inspire and enjoy music". ARM has received and maintained its federal tax-exempt status through the North American Folk Alliance Group Exemption Program (Group # 8047) since 2007.

The American River Music Festival has been and remains the primary project for ARM. The 2012 festival will be held on September 14~15~16 at the Henningsen-Lotus County Park and three sponsoring campgrounds. The campgrounds are Camp Lotus, American River Resort and Earthtrek.

ARM has successfully organized and operated the festival since 2007. The shuttle service is a necessary operation of the festival as parking is extremely limited at Henningsen-Lotus Park. The shuttle service provides air pollution reduction and increased traffic safety for the patrons and community.

The festival's shuttle manager is Jim Plimpton, an ARM board member with a great deal of previous shuttle/bus experience. He has successfully organized and operated the festival's shuttle system since 2007. ARM successfully completed the shuttle project at the 2007, 2008, 2009, 2010 and 2011 festivals.

ARM contracts with Coloma – Lotus based Professional Rafting Outfitters to operate the bus shuttles. The anticipated outfitters are Whitewater Connection, All Outdoors, River Runners, and Adventure Connection. All outfitters have in excess of 10 years in shuttle services and have contracted with ARM for its shuttle services since 2007. All outfitters name El Dorado County as additionally insured and carry the necessary insurance to meet El Dorado County requirements. All drivers are employees of the outfitters and carry the necessary Ca driver's license for passenger buses operation.

ARM needs AB2766 funds as the estimates for contracting for buses is a large line item expense of the festival's budget. The festival has been 100% organized and operated through volunteers since 2007. Estimates from Rafting Outfitters are based on anticipated fuel costs, insurance, driver expenses, and the outfitter's commitment to the festival's continuing success. ARM anticipates a \$6,500 project cost.

Funding Request/Breakdown of Cost

ARM respectfully requests \$5,200.00 of AB2766 DMV Surcharge Funds. The fund request is for a project budget based upon the amount of matching funds paid by American River Music, Inc.

The festival takes place on September 14~15~16, 2012 in Coloma, and anticipates up to 1000* shuttle users (ticket buyers, volunteers, musicians, vendors and staff) camping and lodging in the festival's three sponsoring campgrounds (American River Resort, Camp Lotus and EarthTrek).

ARM will contract for 5 buses and 3 vans to shuttle these folks to the main stage area (Henningsen-Lotus Park) and back to the campgrounds between the hours of 9:30 A.M.- 7:00 P.M. on September 15~16 which are the main stage operating hours.

The \$5,200.00 request is based upon the project cost of \$6,500 reflecting bus/van contract quotes from Whitewater Outfitters in the Coloma-Lotus Valley. Tentative outfitters are All-Outdoors, Whitewater Connection, The River Store, Adventure Connection and River Runners. Bus rental fees are estimated to be \$575/day, and van rentals to be \$125/day.

This cost is significantly below Charter Bus (Liberty Coach, Great American Stage) rates because the buses are stationed within 1 mile of Henningsen-Lotus Park, and the local companies have an interest in seeing the festival project of ARM continue. Charter Bus quotes are as much as \$1500/day.
