Project Description: The El Dorado County Fire Safe Council (EDCFSC) proposes the following program for grant funding made available by the El Dorado County Air Quality Management Board and AB 2766, adopted into the California Health and Safety Code and collected through the California Department of Motor Vehicles (DMV) motor vehicle registration clean air surcharge. This application for funding requests assistance to coordinate and implement a 2012-2013 Community Green Waste (GW) Dumpster and Residential Chipping Program that provides two viable alternatives to the transport of multiple truck loads of green waste over El Dorado County roads. EDCFSC proposes a program that will provide free dumpster and chipping services to eligible west slope El Dorado County residents in remote and rural communities and residents leasing property in the Federal land tracts along the Highway 50 corridor. The program is incentive based to encourage County residents to create defensible space around their dwellings and structures before catastrophic wild fire occurs and to reduce motor vehicle emissions, fugitive dust, and burn pile emissions. EDCFSC requests funding support to assist County residents in complying with California Public Resource Code PRC 4291 that requires 100 feet of defensible space around each structure, and the El Dorado County Air Quality Management District's goal in reaching "Vehicle Miles Traveled (VMT) Trip Reduction", "Public Education" and "Biomass Transport Reduction". California is in a critical situation with population growth estimated to reach 60 million by the year 2025. Funding is crucial for the EDCFSC to continue creating awareness and fire safe education, as well as assist in providing on the ground resources to residents that promote defensible areas, community and neighborhood clean-ups and fuel reduction projects.

#### **Project Description**

In an effort to provide alternatives to the transportation of numerous truck loads of green waste vegetation along El Dorado County roads, the EDCFSC is proposing the implementation of a two part program that will provide green waste dumpsters and chipping services to residents in remote and rural communities on the west slope of El Dorado County, and residents leasing property in Federal land tracts along the Highway 50 corridor. The program provides incentives to create defensible space around dwellings and structures before catastrophic wild fire occurs, and to reduce motor vehicle emissions, associated fugitive dust, and burn pile emissions.

The first option is the Community GW Dumpster Program. Upon request by communities, neighborhoods and local satellite fire safe councils, large green waste dumpsters are placed in strategic locations for coordinated clean-up days. A minimum of three residences is required to participate. The dumpster service is coordinated between the EDCFSC and the disposal company. One local volunteer becomes the group contact that works directly with EDCFSC to coordinate an event within their respective area. The residents and other volunteers collect the green waste material and place it into the GW dumpster(s) to be picked up at the end of two weeks by the disposal company. In some cases a container is filled early and arrangement is made to retrieve and drop another. In all cases, the lead volunteer coordinates this service through the EDCFSC. Dumpsters filled with green waste are transported to a material recovery facility (MRF) to be processed into biomass that is used as a soil additive or fuel source for clean energy production. The Community GW Dumpster program is designed to reduce ground level/ladder fuels and reduce vehicle road trips made by residents to disposal sites. These efforts ultimately achieve reductions in fuel exhaust emissions while creating defensible space and a better fire safe environment.

The second alternative is the Residential Chipping Program which provides chipping to individual residents and organized community green waste clean-up projects. Residents and volunteers perform the fire fuel clean-up and stack the piles of vegetative material along accessible roads that will be chipped into biomass material at a future scheduled date. The individual resident submits a request for the service to EDCFSC online, by phone or U.S. Mail. EDCFSC coordinates the service with the chipping contractor. The contractor schedules the work to be performed by the field crew and makes contact with the resident a few days prior to arriving at the site. Normally the contractor coordinates and schedules multiple jobs at consecutive sites within a community, neighborhood or residential site on the same day to reduce driving distance and economize fuel. Processed wood chips are left at the resident's property to be used as groundcover which reduces CO emissions. The material can also be placed into a placed into a community GW dumpster that is transported to the MRF. The program provides a viable means of processing green waste on site, versus transporting multiple truck loads of material to a disposal facility or burning it on site. Previous years' data collected by EDCSFC substantiates that the majority of residents choose to burn when chipping is not an option due to cost, physical limitation, or lack of equipment to perform the task themselves. Others have noted that they would haul the material elsewhere, or leave it as is which can become a major fire fuel source.

New to the program is the development of a web based reporting program. Residents continue to submit their requests for service online which automatically uploads into the master data base. The information is stored and made available to the chipping contractor(s) to schedule appointments and review project status. Request received by mail will be entered online by EDCFSC personnel. Once a job is completed, the contractor enters the work/job order information onto another on-line form that automatically uploads to the master data base. This database will be used for tracking, monitoring, invoice reconciliation, and reporting.

#### Project Organization/Background

The mission of the El Dorado County Fire Safe Council (EDCFSC) is to protect the people of El Dorado County and their property from the effects of catastrophic wildfire through education, cooperation, innovation, and action. EDCFSC was formed in 2001, incorporated in May 2002, and received a Letter of Determination from the IRS as a 501(c) (3) nonprofit, public benefit corporation on July 8, 2002. Having completed the IRS advanced ruling period and successfully completing all of the required Supporting Documentation, the IRS has classified the EDCFSC as a public charity organization exempt from Federal Income Tax under section 501 (c) (3) of the IRS code per their letter of October 25, 2006.

The EDCFSC goal is to organize and assist in new satellite fire safe council (SFSC) formation and to provide on-going support to its established SFSCs and affiliates that serve the residents of El Dorado County and convey the message of the value of becoming a Firewise USA Communities (Title III \$60K). Currently there are five recognized Firewise communities - Auburn Lake Trails, Grizzly Flats, Logtown, Nashville/Sand Ridge and Volcanoville, and 16 satellite fire safe councils on the west slope of El Dorado County. The role of the local SFSC is to welcome and educate new residents to their community and share the message on the importance of defensible space against wildfire and the value and opportunities related to the "fire safe" culture.

EDCFSC has received grant funding to implement numerous projects over the years, and most recently, the 2010-2011 projects include the Residential Chipping (USFS \$306.4K), Community Green Waste Dumpsters (USFS \$110.0K), Senior and Disabled Assistance program (USFS \$100,364), Grizzly Flats Fuel Break (USFS \$338.15K), Gold Hill Fuel Break (USFS \$75K), Happy Valley Evacuation Route (USFS \$40K), Volcanoville Fuels Reduction (USFS \$65K), Nashville/Sandridge Evacuation Route (USFS \$40.87K), Hwy 50/49 Corridor CWPP (Title III \$80K), and the Logtown Monitor Fuel Break (CAL FIRE \$95K). The projects that were completed in 2011 include: Grizzly Flats 6/7, Volcanoville Evacuation Route and Community Action Plan, the Nashville/Sandridge Evacuation Route and Diamond Springs/El Dorado/Highway 50 Corridor CWPP projects. The 2010 Senior/Disabled Assistance is nearly depleted and scheduled to end in June 2012. The 2011/2012 Chipping and Dumpster program is estimated to remain active through September 2012 (USFS \$200.2K). The EDCFSC received a partially funded grant from the U.S. Forest Service to assist in extending the program, estimated into early 2013 (USFS \$112K).

The EDCFSC, its SFSCs and affiliates continue to champion the Residential Chipping and Dumpster Program which was developed to promote and develop 'defensible space' through organized community clean-up events, neighbor-to-neighbor projects, and individual activity. The focus is to reduce hazardous brush and ladder fire fuels around structures and along the driveways in El Dorado County. Between January 2010 and December 2011, more than 631,000 cubic yards of material was chipped and 1,690 cubic yards of green waste was removed in GW dumpsters. The program provides residents with an alternative to transporting material individually or burning. The chipping service provides communities and residents a means of disposing of their green waste. Piles of brush and branches are stacked along driveways or lightly traveled roadways to be chipped on site. The chips are left on the landowner's property to be used as mulch. GW dumpsters are made available to encourage neighborhood residents to take the opportunity to dispose of branches, trimmings, leaves, and other hazardous fuel materials for free, which eliminates the need to transport the GW themselves which would require multiple trips to the MRF.

EDCFSC assists the County and its residents in reducing vehicle emissions through its on-site chipping and dumpster programs. Both services provide alternative methods of processing green waste and eliminating the need for travel to a MRF. The chipping service leaves chipped material at the job site that is spread on the ground surface as mulch which reduces the amount of carbon that would otherwise rise from the soil into the atmosphere. The chipping contractor works towards coordinating jobs that are within close proximity to one another and within communities and neighborhood in an effort to reduce travel and save fuel. The dumpster program provides a 30 yard dumpster to reduce the number of road trips by a resident to the MRF. The dumpster containers have a capacity approximately 15 times more than that of a light duty truck that may hold two (2) cubic yards of material at best. To be noted, a dumpster vehicle must make two round trips to drop off a container at a site and then retrieve it, versus a resident who potentially will make up 15 round trips. Another important consideration in reducing vehicle emissions is today's strict vehicle emissions standards. Many waste management companies have chosen to convert their fleet inventory to vehicles that use alternative fuels that produce little to zero emissions. This is definitely a win, win situation for participants in this program and for all of us living in this environment.

#### Matching Funds

The time spent cutting and hauling material to GW Dumpsters will be estimated at two hours per yard and the capacity of the dumpster. All estimates for this proposal are based on records from the 2010 Chipping - Green Waste Dumpster program. All homeowner time is valued at the current State of California minimum wage which is \$8.00 per hour. The estimated match values are summarized in the table below and equal an estimated 47% in-kind matching contribution to the proposed program.

#### Schedule of Deliverables/Self-Monitoring Program

In 2002 the EDCFSC began its residential chipping program to assist El Dorado County residents in creating defensible space around their dwellings and structures at no monetary cost for the service. Over time and participant feedback, the EDCFSC refined its processes to increase efficiencies and reduce cost. Today's program utilizes online residential requests for chipping that are re-entered into an Excel database. The contractor enters the scheduling, the resident request, and the completed job/work order information. A monthly invoice is submitted to EDCFSC with a copy of the master file. Occasionally, EDCFSC places a request to the contractor to provide the updated Excel master file. This system is functional but requires additional time, the potential for data entry errors, and the inability to view residents' project status or encumbrance data. In an effort to improve process, increase efficiency and reduce cost, EDCFSC has initiated the development of a full web-based program that continues to serve residents and enables them to submit their chipping requests online. The difference with this scenario is the information will automatically transfer to the master database. The contractor(s) will continue to enter their schedule and completed work order information, onto the new online form that posts directly into the master database. The result is near real time access to view program activities such as resident requests for service, scheduling information, analyze service demands, monitor program encumbrances, provide invoicing verification, and program statistics that will be used for reporting purposes. It continues to create a cost-effective and efficient solution, while maximizing resources enabling EDCFSC to stretch limited funding.

Success of the program is measured on a yearly basis by satisfaction surveys that are conducted in the field. Additionally, the physical analyses of the program are measured by the number of program participants and cubic yards of hazardous fuels that is removed from parcels. In the long term the measurement of success is more subjective and can be measured by recognizing the changing attitudes of residents that are willing to create their own defensible space and fire safe environment without the need for outside subsidies. Our long term goal is to continue education and to promote the need for fire safe practices while creating fire safe communities, and spreading the word that, "Fire safe is a way of life in the El Dorado County Wildland Urban Interface (WUI) we live."

The Placerville Ranger District of the Eldorado National Forest is pleased to submit this letter in support of the El Dorado County Fire Safe Councils' application for the Community Green Waste Disposal Program for the Forest Service Recreation Residence Tracts and remote/rural areas along the American River Canyon.

The Forest Service Recreation Residence Program gives private citizens the opportunity to own a single-family cabin in designated areas on the National Forest. These privately owned cabins are located within formally established tracts on lots designated for that purpose and are authorized and administered under the terms and conditions of a special use permit. The individual owns the improvements but not the land. The American River Canyon/Highway 50 corridor has approximately 28 recreation residence tracts and over 600 cabin lots in the program.

A condition of a recreation residence special use permit is that annual fire clearance is completed to provide a defensible space. Dumping pine needles, wood chips, slash and other vegetation (fuel material) on National Forest lands is not permitted and as a result cabin owners and adjacent private home owners are often driving over two hours roundtrip to the local landfill to properly dispose of their burnable materials. Having local green waste drop sites strategically placed along the tracts encourages residents to create a defensible space for their tracts and communities. Through a green waste program, various convenient locations would be available to homeowners to dispose of hazardous fire fuel vegetation cleared from around their cabins, homes and evacuation routes.

The goal of the proposal would provide a multitude of benefits to the National Forest. These benefits include defensible space for wildlife fire, enhanced outdoor recreation, reduction of smoke from door yard burning and collaboration with other organizations in an ongoing effort to reduce fuels and lower fire hazards. This proposal would also help cabin holders meet the required State Fire Law.

On behalf of the Volcanoville Fire Safe & Firewise Council, I am writing in support of the grant proposal being submitted to the El Dorado County Air Quality Management District for the EDC Fire Safe Council's Community Green Waste Dumpster and Chipping Program.

Volcanoville is a small community east of Georgetown which has 327 full time and 122 part time residents, and 225 residences. Because of the distance to the waste management facilities in this county, (at least a one hour drive to Diamond Springs) many residents burn the dead and overgrown vegetation around their homes. However, over the past few years, several of our local residents have chosen to participate in the Community Green Waste Dumpster and Residential Chipping Program.

This program has assisted our area and the West Slope of El Dorado County in reducing air pollution by providing alternatives to traveling or burning. The Green Waste Dumpster program reduces the number of vehicle trips on county roads thus eliminating fuel exhaust emissions. The Residential Chipping program slows CO2 emissions from the ground as residents cover the soil with the chipped material. # El Dorado County Fire Safe Council 2011/2012 Residential Chipping Program "Public and Private Partners Working Together to Protect People, Homes and Natural Resources"

The EDCFSC has received grant funds to provide chipping for people who are clearing their property to create defensible space. All you need to do is complete the items below:

- □ Create defensible space by clearing brush 100' from buildings and 20' from roads. Refer to Cal Fire Guidelines on creating defensible space at: <u>www.fire.ca.gov</u>. We encourage participants in the program to have a residence on the property. Scheduling priority will be given to those who have a residence on the property.
- □ Place brush piles so the chipping machine and crew can have access. The piles need to be adjacent to a driveway or street. Preferably pile brush on the uphill side. Do not place piles along busy, heavily traveled roadway, where signage or additional crew would be required by County or State Code for safety. This is not covered under the Fire Safe Council's contract. Recently removed vegetation will chip better than old dried out branches and shrubs.
- □ It is easier and more efficient to chip the piles if they are wider and spread out rather than taller. All the cut ends need to be facing the same direction. Please follow the diagram below for additional instruction on preparing your piles.
- □ The chipper can handle material up to 7" in diameter (no root balls). The equipment does not chip individual branches that are small (rakings) or old-decayed wood well.



- Keep all piles free of rocks, dirt, wire, lumber, spiny plants, poison oak, and blackberries. The chipper can not chip piles of pine needles or leaves. You can dispose of this material in green waste dumpsters.
- The FSC requires the "Request for Chipping" form be completed and signed before chipping is done on your property. The form can be completed on our website at: <u>www.edcfiresafe.org</u> or you can mail your signed form once your piles are ready for chipping. The Fire Safe Council does

not operate equipment on RED FLAG warning days as determined by the National Weather Service. If you are scheduled for chipping on a day that is a RED FLAG warning day you will be rescheduled.

- □ Pre-inspections are available upon request.
- □ You do not have to be home the day you are scheduled for chipping. The EDCFSC will provide a maximum of 1-day chipping services per residence per year.
