

## Proclamation of the El Dorado County Board of Supervisors Recognizing Mr. Hal Erpenbeck For Dedicated Service to the Citizens of El Dorado County and El Dorado Hills

Whereas, Hal Erpenbeck, 76 years old, was born in Chicago, Illinois, is a United States Army Artillery Veteran, has served as an officer of the Benevolent and Protective Order of Elks, is the proud father of two sons, Doug and Mark, and lives with his wife, Barbara in El Dorado Hills since 2002; and

Whereas, Mr. Erpenbeck has provided key leadership to numerous civic organizations and has been instrumental in bettering his community and the County, including;

- Cofounding the Clarksville Region Historical Society in 2006, helping to celebrate, preserve and protect the County's Gold Rush roots; and
- Establishing an El Dorado Hills Community Service District Foundation, and among many other things, advocated for reform on Park Impact Fees; and
- Helping to launch a local history research program at Oak Ridge High School; and
- Serving as a Member of the Commission on Aging since 2009, working to improve senior services including, nutrition, day care, and creating the website <u>www.2nd50years.org</u>; and
- Volunteering at the El Dorado Hills Library, helping to improve technology, implementing a database application with key analysis, designed a software program to register families for early literacy, also a way to track youth programs for expanded grant opportunities and reporting compliance, brought about an entrance marquee for events information and put together a very popular history kiosk; and
- Serving as a member of the El Dorado County Grand Jury for more than one term; and
- Volunteering at the Marshall Gold Discovery State Historic Park in Coloma as a costumed docent and implementing a software program to manage the park library; and
- Leadership on the Community and Economic Development Advisory Committee of El Dorado Hills, helping to coalesce consensus on community identity and goals; and
- Serving as Liaison to the El Dorado Hills Community Foundation; and
- Serving as an Alternate Member on the County Charter Review Committee; and
- Leadership for the expansion of the Senior Day Care center in El Dorado Hills.
