Re: Pending Business Name Change

Dear Ms. Silacci-Smith,

Pursuant to the terms of an agreement between Pacific Systems Integrators, Inc. (PSI) and *Corrections Technology Group, LLC (CTG)* these two companies will be joining forces. CTG is very similar to PSI in that they provide maintenance and upgrades for detention facilities throughout the western region of the U.S. Like PSI, their personnel have extensive training and experience in detention work, having designed, fabricated, installed, and maintained detention electronic controls and hardware throughout the country.

The great benefit of this change for your facility(ies) is that CTG has more personnel and resources than PSI. By joining forces, the amalgamated entity will be able to provide a higher level of service to all our clients. Through CTG you will now have access to a larger pool of qualified detention professionals, including installation and maintenance technicians, an engineering group and electronic controls fabrication shop, as well as dedicated marketing and office staff, all available to serve your detention facility needs. The PSI personnel with whom you have become familiar will now be able to focus more completely on facilities maintenance and upgrade issues.

The new entity will carry on under the Corrections Technology Group, LLC name. Whereas PSI holds CSLB license #931794 with B, C10, C7, and C28 licenses, Corrections Technology Group, LLC holds CSLB license #997482 with C10, C7, and C28 licenses. In that PSI's "B" license has never been used to perform any of its maintenance or upgrade work, there will essentially be no change in license qualifications under the new name.

The date established in the agreement between PSI and CTG for the amalgamation and name change is **March 1, 2016**. We realize it may take some days or weeks longer to complete the necessary paperwork, and we will do everything we can to help facilitate the process.

To that end, new insurance documents in the new business entity name and as required by contract will be forwarded to you soon - if you haven't already received them. If you require any additional documentation to amend our service contract to reflect the new name, please send that information to:
