# WHAT DOES THE MONEY BUY? (FAQ #7 - partial):

...BSCC to administer a grant program to public agencies aimed at supporting mental health treatment, substance abuse treatment, and diversion programs for people in the criminal justice system, with an emphasis on programs that reduce recidivism of people convicted of less serious crimes, such as those covered by this measure, and those who have substance abuse and mental health problems. {Government Code Section 7599.2 (a)(3)}

## **MONEY, THE ESTIMATES** (FAQ #6 – partial)

On January 7, 2016 the Governor's Budget included an estimate of state's first-year savings resulting from the implementation of Proposition 47 at \$29.3 million. Sixty-five percent of that (just over \$19 million) will be allocated to the BSCC to be distributed as recidivism-reduction grants.

1<sup>ST</sup> YEAR ESTIMATE: to BSCC: \$19 million
2<sup>nd</sup> YEAR ESTIMATE: to BSCC: \$26.3 million

• ONGOING SAVINGS: to BSCC: \$37.4 million annually
