8. 16-0437 Indirect Cost Committee Update

He is looking for information on how indirect and administrative costs were calculated for FY 2014-15, what the breakdown is between traditional mental health programs and MHSA programs, what is the indirect percentage rate, and what the allocated costs are to each program. Director Ashton stated that budget staff could provide a presentation on this along with the budget items being presented at the next meeting.
