Fiscal Impact/Change to Net County Cost: No change to net County cost. County will receive two installments of \$62,500.00 (March 1, 2009 and August 1, 2009) based on completion of specified project criteria.

Background: On October 14, 2008 El Dorado County Health Services Department - Public Health Division, on behalf of ACCEL (Access El Dorado - a coalition of safety net providers) submitted to the Board, and received approval for, a grant application request. This grant provides specifically for the continuation of work toward implementation of an electronic Health Information Exchange (HIE) to enable the healthcare providers in El Dorado County to share clinical and administrative information.

Grant award documents were received by Department December 24, 2008 and staff immediately prepared for next available Board date.

Reason for Recommendation: Grant funds will be utilized for (1) review and approval of vendor for HIE system implementation; (2) adoption and execution of a strategic business plan that addresses long-term sustainability of the HIE; and (3) implementation of the HIE project linking Barton Healthcare system with El Dorado County Health Services Department - Public Health Division.

- 3. **Evaluation and Monitoring**. The Foundation may monitor and conduct an evaluation of operations under this grant. This may include a visit from Foundation staff, Trustees, and/or Foundation advisors, to observe Grantee's program, discuss the program with Grantee's personnel, and review financial and other records and materials connected with the activities financed by this grant. In addition, Grantee shall provide to the Foundation copies of any publications or other materials produced, in full or in part, with Foundation funds.
- 4. Recordkeeping. Grantee shall keep adequate records to substantiate expenditures from grant funds. Grantee shall make its books and records pertaining to the grant funds available to the Foundation at reasonable times for review and audit, and shall comply with all reasonable requests of the Foundation for information and interviews regarding use of grant funds. Grantee shall keep copies of all books and records related to this grant and all reports to the Foundation for at least four years after Grantee has expended the last of the grant funds.
- 5. Sub-grantees. Grantee shall retain full discretion and control over the selection of any sub-grantees or sub-contractors to carry out Grantee's charitable purposes and shall act completely independently of the Foundation. The Foundation and Grantee acknowledge that there is no agreement, written or oral, by which the Foundation may cause Grantee to choose any particular sub-grantee or sub-contractor. Grantee shall require that any sub-grantee or sub-contractor be subject to the requirements of Paragraphs 1, 2, 3, 4, 7, 10, 11, 12 and 13 of this Agreement, substituting Grantee for the Foundation and the sub-grantee or sub-contractor for Grantee, as applicable. All obligations of Grantee under these Paragraphs shall remain in full force and effect.
- 6. Funds Not Earmarked; Grantee Representation. The grant funds are not earmarked to be used in any attempt to influence legislation within the meaning of Internal Revenue Code ("IRC") Section 4945(e). The Foundation and Grantee have made no agreement, oral or written, to that effect. Grantee represents and warrants, here and in its proposed budget for this grant, that the total of all grants from the Foundation for this project to be paid to Grantee within a single annual accounting period of Grantee does not exceed the amount budgeted by Grantee for its accounting period for activities of the project that are not attempts to influence legislation within the meaning of IRC Section 4945(e).
- 7. **Prohibited Uses.** Grantee shall not use any portion of the funds granted:

- 8. Grant Announcements. Grantee shall submit in advance to the Foundation, for review and revision at the sole discretion of the Foundation, any announcements Grantee intends to make regarding the grant, and any publications referring to the grant Grantee intends to publish other than in its annual reports or tax returns. The Foundation may include information on the grant in its periodic public reports and may also refer to the grant in a press release. If there are special considerations concerning the public announcement of this grant, or if Grantee would like to coordinate a public announcement of the grant with the Foundation, Grantee may contact the Foundation to discuss Grantee's plans.
- 9. Representation and Warranty Regarding Tax Status. By entering into this Agreement, Grantee represents and warrants that Grantee is exempt from federal income tax under IRC Section 501(c)(3) or in the absence of such a determination, that Grantee is a state or any political subdivision thereof within the meaning of Code Section 170(c)(1), or a state college or university within the meaning of Code Section 511(a)(2)(B) (referred to hereafter as a "Public Charity") and that it is not a private foundation as defined in IRC Section 509(a) (i.e., that it is a "Public Charity"). The Foundation may also avail itself of any other remedies available by law.

Blue Shield of California Foundation ("the Foundation") has approved a \$125,000 Health Information Exchange (HIE) grant to the El Dorado County Department of Public Health ("Grantee") for the 12 month period 01/01/09 to 01/01/10. Funds provided under this grant are available to former or current Blue Shield of California Foundation (BSCF) grantees, and must be used to strengthen and/or complete core aspects of current projects, to develop long-term strategic plans, or to provide time to secure future funding from other organizations. The key objectives for this HIE project are:

- 1. By March 1, 2009, review and approve vendor selection for HIE system implementation.
- 2. By August 1, 2009, adopt and execute a strategic business plan that addresses long-term sustainability of the HIE.
- 3. By December 31, 2009, implement the HIE pilot project linking Barton HealthCare System with El Dorado County Department of Public Health.

Grant payments will be issued according to the following schedule:

1<sup>st</sup> payment of \$62,500 Issued upon receipt signed grant agreement
2<sup>nd</sup> and final payment of \$62,500 Issued upon receipt and review of interim reporting


