AGREEMENT FOR SERVICES #848-PHD0509 AMENDMENT I Alcohol and Other Drug Counseling Services

This Amendment I to that Agreement for Services #848-PHD0509, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and Tahoe Youth & Family Services, Inc.; (hereinafter referred to as "CONTRACTOR");

RECITALS

WHEREAS, CONTRACTOR has been engaged by COUNTY to provide alcohol and other drug treatment services, in accordance with Agreement for Services #848-PHD0509, dated October 27, 2009, incorporated herein and made by reference a part hereof; and

WHEREAS, COUNTY allocates a portion of the State funding for the Alcohol and Other Drug Counseling program to various treatment service providers at the beginning of the fiscal year. This allocation is based on anticipated numbers of clients and services, derived from historical usage; and

WHEREAS, COUNTY has received information from the California Department of Public Health that based on the Cost Report findings for fiscal year 2008-09, a portion of the FY 2008-09 allocation from the State to the COUNTY for the Alcohol and Other Drug Counseling program remains unspent; and

WHEREAS, COUNTY has determined that allocating a portion of these unspent funds to various treatment service providers will ensure increased services over what was originally anticipated to occur during FY 2009-10; and

WHEREAS, the parties hereto have mutually agreed to increase both the Provisional and the Total Not-to-Exceed amounts of said Agreement, hereby amending Article IV, Section 4.02 (a); and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #848-PHD0509 shall be amended a first time as follows:

A-1, 848-PHD0509

Article IV, Section 4.02 (a) shall be amended in its entirety to read as follows:
