

AGREEMENT FOR SERVICES #049-162-P-R2011  
AMENDMENT I

This Amendment I to that Agreement for Services #049-162-P-R2011, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as County) and El Dorado Union High; (hereinafter referred to as EDUHSD).

**RECITALS**

**WHEREAS**, EDUSHD is making available District Funds (non-Federal) for the purpose of improving education and vocation learning potential as well as physical and mental health of all students and their families in accordance with Agreement for Services #049-162-P-R2011, dated June 14, 2011 , incorporated herein and made by reference a part hereof; and

**WHEREAS**, the Health Services Department been reorganized and is now known as Health Services, a Department of the Health and Human Services Agency; and

**WHEREAS**, the parties hereto have mutually agreed to amend the term of the original Agreement, *Article III - Term*; and

**WHEREAS**, the parties hereto have mutually agreed to increase the not-to-exceed amount of the original Agreement, by amending *Article IV – Compensation For Services*; and

**WHEREAS**, the parties hereto have mutually agreed to amend *Article XI - Notice to Parties*;

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #049-162-P-R2011 shall be amended a first time as follows:

- 1) All references in the original agreement to the “County Health Services Department” or “HSD” shall be deemed to refer to Health Services, a Department of the Health and Human Services Agency.

2) Article II, Term shall be amended in its entirety to read as follows:

**Article III. TERM**

This Agreement shall become effective upon final execution by both parties hereto and shall cover the period of July 1, 2011 to June 30, 2013 unless earlier terminated pursuant to the provisions under Article X herein.

3) Article IV, Compensation for Services shall be amended in its entirety to read as follows:

**Article IV. COMPENSATION FOR SERVICES**

COUNTY shall submit quarterly invoices to EDUHSD; payment to COUNTY for services described herein shall be within thirty (30) days of receipt of invoice. Compensation for services provided under this Agreement shall not exceed \$60,000 as follows:

July 1, 2011 through June 30, 2012	\$30,000
July 1, 2012 through June 30, 2013	\$30,000
<b>Total not-to-exceed for term of Agreement:</b>	<b>\$60,000</b>

4) Article XI, Notice to Parties shall be amended in its entirety to read as follows:

**Article XI. NOTICE TO PARTIES**

All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to COUNTY shall be addressed as follows:




