AGREEMENT FOR SERVICES 099-S1210 AMENDMENT III

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement, thereby amending Article II – Term, update contact information thereby amending Article XVIII – Notice to Parties and Article XXVII – Administrator.

1) Article II shall be amended in its entirety to read as follows:
