### AGREEMENT FOR SERVICES 624-S1211 AMENDMENT I

THIS AMENDMENT I to that Agreement for Services 624-S1211, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Star View Adolescent Center, Inc., a California corporation qualified to conduct business in the State of California whose principal place of business is 4025 West 226<sup>th</sup> Street, Torrance, CA 90505 (mailing: 1501 Hughes Way, Suite 150, Long Beach, CA 90810) (hereinafter referred to as "Contractor") whose Agent for Service of Process is Ed Hoefle, 4025 W 226<sup>th</sup> Street, Torrance, CA 90505.

#### RECITALS

WHEREAS, Contractor has been engaged by County to provide twenty-four (24) hour residential services for County-authorized minors with serious emotional problems (hereinafter referred to as "Client" or "Clients") in accordance with Agreement for Services 624-S1211, dated September 4, 2012, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement, thereby amending Article II – Term, and increase the Not-to-Exceed amount of the Agreement, thereby amending Article II – Compensation for Services.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services 624-S1211 shall be amended a first time as follows:

1) ARTICLE II shall be amended in its entirety to read as follows:

#### ARTICLE II

**Term:** This Agreement shall cover the period of March 15, 2012 through March 31, 2017 unless earlier terminated pursuant to the provisions under the Articles titled "Fiscal Considerations" and "Default, Termination and Cancellation" herein.

- 2) ARTICLE III, paragraph A shall be amended in its entirety to read as follows, and shall become effective upon final execution of this Amendment I to Agreement 624-S1211:
- A. <u>Rates:</u> Rates for services provided in accordance with this Agreement shall be as set forth herein below. Any change to rates shall be modified by mutual consent, in accordance with the Article titled "Changes to Agreement" herein.
