

**SACRAMENTO METROPOLITAN AIR QUALITY MANAGEMENT DISTRICT
EL DORADO COUNTY AIR QUALITY MANAGEMENT DISTRICT
MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (MOU) is between **Sacramento Metropolitan Air Quality Management District (SMAQMD)**, a California local public agency and **El Dorado County Air Quality Management District (El Dorado AQMD)**.

1.0 Recitals

- 1.1 SMAQMD and El Dorado AQMD are part of the Sacramento Federal Ozone Nonattainment Area (SFNA).
- 1.2 The SFNA received a grant under the Congestion Mitigation and Air Quality Improvement (CMAQ) Program. The CMAQ Program requires grant recipients to allocate 11.47% in matching funds against the total CMAQ grant.
- 1.3 The El Dorado AQMD wishes to provide \$6,218.88 to SMAQMD to be used as El Dorado AQMD's local match covering CMAQ grant #9 for the regional Spare The Air Program.
- 1.4 The regional Spare The Air Program has been a central part of the SMAQMD Community Outreach Program since 1995.
- 1.5 The ongoing elements of the regional Spare The Air Program include daily ozone forecasting from May through October, publication of ozone forecast through www.SpareTheAir.com, the Air Alert email notification system, and traditional media; coordination of a Spare The Air Partner network designed to disseminate air quality information, and extensive public education and outreach.
- 1.6 The Spare The Air Program is updated each year to effectively serve the region's residents.
- 1.7 SMAQMD Resolution No. 2010-029, dated August 27, 2010, authorizes the APCO to accept funds from other entities, if the funds will be used to further the mission of SMAQMD.

NOW, THEREFORE, in consideration of the mutual promises hereafter set forth, SMAQMD and El Dorado AQMD agree as follows:

2.0 Terms and Conditions

2.1 Purpose of MOU

The purpose of this MOU is to set forth the expectation of El Dorado AQMD and SMAQMD regarding El Dorado AQMD's contribution of **\$6,218.88** to SMAQMD as local matching funds for the regional Spare The Air Program covering CMAQ grant #9.

2.2 Term of MOU

The term of this MOU will commence upon full execution and terminates **June 30, 2015**.

2.3 Spare The Air Program

SMAQMD will continue to operate the Spare The Air Program as described in Exhibit A, which is attached hereto and incorporated herein by this reference and SMAQMD will use the funds received from El Dorado AQMD under this MOU for the sole purpose of funding that program.

2.4 Payment

SMAQMD will invoice El Dorado AQMD in September 2014 in the amount of **\$6,218.88** for CMAQ grant #9 and El Dorado AQMD will likewise remit payment to SMAQMD by **November 30, 2014**.

2.5 Indemnification

- a. SMAQMD will indemnify and defend El Dorado AQMD, its officers, agents and employees from and against all claims, demands, losses, damages, liability, costs, and expenses of whatever nature including court costs and attorney fees, whether for damages or loss of property, injury to or death of person, or economic or consequential loss arising from or related to or claimed or alleged to have arisen from or been related to the negligence of SMAQMD in the performance of its obligations under this MOU.
- b. El Dorado AQMD will indemnify and defend SMAQMD, its officers, agents and employees from and against all claims, demands, losses, damages, liability, costs, and expenses of whatever nature including court costs and attorney fees, whether for damages or loss of property, injury to or death of person, or economic or consequential loss arising from or related to or claimed or alleged to have arisen from or been related to the negligence of El Dorado AQMD in the performance of its obligations under this MOU.

2.6 Termination

Either party may terminate this MOU at any time by providing the other party written notice.

2.7 Communication

All written communications regarding this MOU must be either personally delivered or sent by prepaid, certified first class mail, return receipt requested, addressed as follows:

- A. **Change of Address:** Either party may change the address for service by giving 15 days advance written notice to the other party.
- B. **Effective Date:** All notices will be effective upon receipt and will be deemed received (i) upon delivery if personally delivered, (ii) on the 5th day following deposit in the mail, if sent by certified mail, or (iii) upon the date stated in the facsimile delivery confirmation, if sent by facsimile.

2.8 Audit of SMAQMD Records

With regard to this MOU, SMAQMD will maintain appropriate financial records and El Dorado AQMD may demand access to these financial records to perform an audit. SMAQMD must make these records available to El Dorado AQMD thirty (30) days after receiving a request for the records from El Dorado AQMD. SMAQMD must maintain records for 5 years after the termination of the MOU.

2.9 Severability

If any provision of this MOU is held invalid or unenforceable, its invalidity or unenforceability will not affect any other provisions of this MOU, and this MOU will be construed and enforced as if the invalid or unenforceable provision had not been included.

2.10 Statutory Limitations

This MOU and any payments for compensation and expenses are subject to the provisions and limitations imposed by federal and state law. El Dorado AQMD has no liability for payment of any compensation and expenses that are found to be in contravention of federal or state law. SMAQMD will reimburse El Dorado AQMD for any funds paid by it under this MOU that are later determined to be in contravention of any federal and state law.

2.11 MOU Manager

Christina Ragsdale is SMAQMD's named Contract Manager for this MOU. It is the responsibility of the Contract Manager to: 1) verify compliance with the terms and conditions of the MOU, 2) determine that the work has been completed, and 3) submit an invoice to El Dorado AQMD.

2.12 Authority to Bind: The persons signing on behalf of the parties to this MOU warrant that they have the legal authority to execute this MOU.

Exhibit A Scope of Services

The Spare The Air program is an ongoing, regional, seasonal public outreach program that asks motorists to reduce driving on forecasted high-ozone days. The program provides air pollution forecasts, advisories and real-time air quality data so residents of the Sacramento region can protect the health of themselves and their loved ones. It has been approved as a Transportation Control Measure (TCM) in the State Implementation Plan (SIP). SMAQMD's Communications Office operates the Spare The Air program on behalf of the Air Districts of the Sacramento region, including El Dorado County Air Quality Management District, Feather River Air Quality Management District, Placer County Air Pollution Control District, and the Yolo-Solano Air Quality Management District.

Major Objective:

This program seeks to reduce vehicle activity through voluntary reduction of vehicle miles traveled (VMT), number of trips, or both.

Project Location:

The Regional Spare The Air program is operated in the Sacramento Federal Nonattainment Area (SFNA), which includes all of Sacramento and Yolo Counties, the eastern portion of Solano County, the southern portion of Sutter County and the western portions of Placer and El Dorado Counties.

Project Components:

- Regional ozone forecasting/reporting
- Regional ozone mapping
- Regional Spare The Air website – www.SpareTheAir.com
- Regional Air Alert email notification program
- Paid broadcast, print and other media
- Employer and community outreach program
- Collaboration with transit agencies, business and TMAs
- Special promotions and community events
- Social media (Twitter, Facebook, Instagram)

Target Population:

The program targets the entire population of the SFNA, especially drivers and those with respiratory illnesses.
