Good Morning Kelly -

In negotiating the above-referenced lease, I was able to get the property owners to agree to no 2% increase for five years -

but, then after five years, they are requesting that we go back to the 2% per year increase.

Because it is five years in the future, I have no problem with getting five years now with no 2%; and then revisiting this in five years. The lease runs five years with three additional 5 year options.

Since the Request for Leased Space that you signed states "No 2%

increase." (period)
