Dear County Official,

Access to Slab Creek at the Mosquito Road Bridge on the South Fork American River in El Dorado County is extremely important in my frequent visits to the county.

I come to kayak and raft on the Slab Creek run and other parts of the American River in El Dorado County. I bring my family and friends who often visit local agriculture producers of wine, olives, apples and other local crafts while we kayak. Our spending easily exceeds \$1200 for a weekend with lodging, restaurant meals, purchases and services for the 3 kayakers and 9 others family members who come with us from 3 households.

Interfering with the public use of a navigable river, is a reduction of liberty and against the values our country was established on.

Using distance and no parking areas to prevent the public form accessing the South Fork American River at Mosquito Road Bridge is unwise for the local economy as it discourages visits.

Requesting public access to the river does not equate to El Dorado County building recreational facilities or having to spend resources.

The county did not fully vet all alternatives to providing access at Mosquito Road Bridge and is rushing ahead without considering the overall impact to the community and local workers.

I urge you to continue to allow the access to the beautiful creeks and rivers in El Dorado county to attract tourists interested in enjoying and preserving the beautiful creeks and rivers in El Dorado County.

Eldorado County should provide access to the river at Mosquito Road Bridge to ensure recreational use of the river is guaranteed to all user groups. This location allows whitewater users a take-out option before class V Motherlode Falls. Limiting access to the river via Mosquito Rd. from 1/2 mile of steep switchbacks will keep most users from accessing the river at all as the walk will be daunting, especially during 100+ degree heat.

Limiting access to a public waterway is in violation of the Navigation Protection Act and Eldorado County should be aware of this. It's Eldorado County's duty to it's citizens to develop recreational facilities for river access.

I am writing to protest the removal of parking and river access at the mosquito road bridge over the south fork American River slab creek run.

It is my opinion that removal of the Bridget will have a negative impact on the quality of river experience and may even lead to fatal consequences as kayakers who are not skilled enough may risk the class 5 rapid downstream (motherload falls) without having the safe takeout at mosquito road. I feel the removal of parking and river access that has been used since the mid 1980s is a decision that is short sighted, illogical and potentially fatal.

I'm urging you to rethink your decision and design into this new bridge parking for 12 cars and access to the river. it will cost far less to do this preemptively then it will to wait until the new bridge is built and design, engineer and build it after.

I understand that on August 16, 2016 the EI Dorado County transportation Division will be giving a presentation to the County Board of Supervisors on the Draft Feasibility Study for Public Access to The South Fork of the American River at Mosquito Road. Hello – I am both a rafter and kayaker who has boated the Slab Creek Run on the Upper American.

This is an epic run whether or not SMUD is releasing 'recreational flows.'

Taking out before the class V rapid is the safest way – so far – to have a successful run. And Mosquito Bridge has been this place.

IMO there should be other options that coincide with any removal or less access at the bridge.

- · Provide a portage trail around Motherlode Falls
 - This is currently an arduous portage and in a raft can take upwards of :45
- · Provide an alternate take-out below the bridge and before Motherlode.
- · Blow up Moterlode and create a lower class rapid (I'm joking here).

Just pulling access to Mosquito Bridge without another plan (and according action) is just so beaurocratic and shows lack of forethought.

The river belongs to all of us so let's take care of ourselves – provide a safe and fun passage for those of us who still enjoy whitewater.

I will be unable to attend the County Board of Supervisors meeting on 8/16, but I would like to make some comments regarding river access at the Mosquito Road Bridge.

I began running the Slab Creek run with friends this year, taking advantage of the new, higher minimum releases that occur from the end of March until the middle of June. We boat in inflatable kayaks and the flows of 180 – 250 cfs are ideal for that run. The run is challenging and it take between 3 and 4 hours to go from the Slab Creek dam put in to the Mosquito Road Bridge. Due to the strenuous nature of the run it is not feasible to continue past the Mosquito Road Bridge to another takeout located downstream. By the time we reach the Mosquito Road bridge everyone is very tired. In my opinion the Slab Creek run is the finest class IV+ inflatable kayaker run in California! I introduced 5 different inflatable kayakers to the run this year. I did the run four different times this year. I plan on running it at least six times per year beginning next year. Since we boat on days that are not recreational releases, there has been no problem with parking near the bridge. Not only is the Slab Creek run a navigable river, it is a gem of a run and forcing me to park 0.5 miles from the bridge would effectively end my ability to kayak this run since inflatable kayaks are not easily carried uphill. No recreational facilities need to be added to the current Mosquito Road Bridge in order for me and my friends to continue to enjoy this resource but I do need to be able to continue to park at the bridge.
