



Changes in Source of Funds

Sheriff

- Reduced use of Rural and Small Counties funding
- Reduction in federal funds King Fire FEMA
- Reduction in Court Security revenues
 - May be adjusted in addenda process, once MOU is final
- Reduction in Homeland Security grant funds
 - May be adjusted in addenda process once awarded



Changes in Use of Funds

- Sheriff Salary Savings
 - Budget assumes salary savings of \$1.1M (reduced from \$2.9M in FY 2015-16)
- Conflict Indigent Defense (Court MOE)
 - Change in service model
 - 15% increase in attorney pay
 - Administrative costs for coordinating firm

Issues / Challenges

- Marijuana
 - Medicinal use/cultivation
 - Potential ballot measure in November to legalize recreational use
- Sheriff sworn salaries may increase in January due to Measure 504
