[16-0448](#) HEARING - Chief Administrative Office recommending the Board open the Budget Hearings, set for September 12, 2016, commencing at 9:00 a.m., to consider adoption of the County of El Dorado Budget for Fiscal Year 2016/17 and direct staff to return on September 27, 2016 with a budget resolution and revised personnel resolution based on discussion and direction received during the budget hearing.

FUNDING: N/A

Supervisor Mikulaco opened the public hearing.

The Board took action on all three items on today's agenda with the motion shown below.

A motion was made by Supervisor Veerkamp, seconded by Supervisor Mikulaco to:

- 1) Close the public hearing;
- 2) Direct that the record reflect information submitted to the Clerk of the Board today includes the request in the amount of \$814,000 for potential fire service augmentation money (See Attachment Labeled "Fire District Augmentation Funding Requests")(to be considered at a future Board meeting);
- 3) Direct staff to:
 - a) Return on September 27, 2016 with a budget resolution to include an increase to the District Attorney's Net County Cost in the approximate amount of \$195,000 and reduce Capital Reserves by the same amount as a result of the loss of grant funding from the Office of Traffic Safety;
 - b) Schedule a workshop pertaining to funding for county roads in November or December of 2016.
- 4) Fire Committee to discuss topics described in item three (3) on today's agenda at their meeting scheduled for next Monday, September 19, 2016 and any subsequent meetings before September 27, 2016 where the Fire Committee will provide an update to the Board.
- 5) Deny Item 2 on today's agenda in favor of consideration of the Pioneer Fire Protection District concurrently with the requests for funding from (five) 5 other Fire Protection Districts.
