Title: Senior Day Care Application for a \$5,000 Alzheimer's Foundation of America Grant

Recommendations:

Human Services, Community Services Division, recommends the Board approve and authorize the Department to submit an application to the Alzheimer's Foundation of America for a \$5,000 grant to purchase equipment to facilitate operations at the new Senior Day Care Center site in El Dorado Hills.

Reasons for Recommendations:

The Senior Day Care Program has been operating successfully since 1989 on a fee for service basis at the Senior Day Care Center on Spring Street. In response to the need to expand services and offer better program access, the Department will be opening a satellite Senior Day Care site at the new Senior Center in El Dorado Hills in the near future. If the application is funded, the \$5,000 grant would be used to purchase some of the minor equipment necessary for program operations at the new site. A copy of the application is on file with the Board Clerk.

Fiscal Impact:

Total Cost (or Savings) Equipment costs for the new site would be partially offset by the \$5,000 grant.

Net County Cost: No change.

Action to be Taken Following Approval:

Department to submit grant application to Alzheimer's Foundation of America by September 15, 2006.

We provide non-medical adult day services to people who are partially or totally dependent on others for their care due to a physical, emotional, mental or cognitive impairment. We specialize in meeting the needs of individuals in the moderate to late stages of Alzheimer's disease and their caregivers.

1. Brief overview of the program:

Expanding access to the dementia care services provided by our existing Senior Day Services Center in the County seat of Placerville by replicating this highly successful model at a satellite site in the far western region of rural El Dorado County.

2. Objectives/goals of the program:

To prevent premature institutionalization of and increase the quality of life for individuals with Alzheimer's disease and related illnesses while reducing the burden experienced by their primary caregiver and to serve more individuals with dementia and their families.

3. Statement of need for this program:

According to the latest census, the 85+ population in El Dorado County, the most atrisk for Alzheimer's disease and placement, is growing at three times the national average. The current center in Placerville is over crowded and there is an on-going waiting list that has exceeded one hundred (100) people many times. Nearly forty percent (40%) of the clients served at the Placerville site live in the far western region of El Dorado County and must endure bus rides to and from the Center that sometimes exceed one hour. 4. Brief description of how funds will be used:

The funds will be used to off set costs associated with the start up of the satellite program. The program will be housed in a newly remodeled portion of the Senior Center in El Dorado Hills.

Clients must be over 18 and have a diagnosis of probable Alzheimer's disease or related illness. They cannot be bedridden or require more than a one-person assist when transferring and must be free of communicable disease.

9. Qualifications of the person(s) administering this program:

Wanda Demarest, Program Supervisor, will administer the program. She has a Bachelor of Science degree in Organizational Behavior and twenty-five years of experience providing dementia specific care and services.

10. How will you evaluate the effectiveness of the program?

Our assessments will indicate an increase in the quality of life for our Alzheimer's participants, a decrease in the burden experienced by their primary caregivers and will indicate that at least eighty-five percent of the participants were at risk of institutionalization without program intervention.

11. How will you fund the program once this grant ends?

This site, like the one in Placerville, will be funded primarily through fees-for-service and donations. It will be self-supporting by its third year of operation.
