Dear Board Members:

Recommendation:

The Department of General Services recommends the Board:

- 1) Authorize the Museum Administrator, Mary Cory, to apply for funds from the California Regrant Project Grant to help fund the re-housing and storage of El Dorado County government historical records. The grant deadline is October 1, 2006.
- 2) Authorize the Director of General Services to execute the Grant Application.

Reason for Recommendation:

The grant, offered through the California State Archives, assists local governments to provide better care of their historical documents and records. The grant requires a match of 25% or more that will be provided through donations of volunteer time to carry out the physical work of transferring files into archive-approved boxes and folders. The first priority is the collection of historical Superior Court case files in the Museum's holdings which receive regular use by genealogists, family members, current Superior Court staff, and other researchers. In order to provide a higher level of long term care, the grant will fund the purchase of standard acid-free archival boxes and folders. Other collections of government historical documents will be re-housed as the supplies funded through the grant are available. The grant will also provide funds needed to improve access to the collection through the creation of finding aids and will fund training at a qualified workshop, such as offered by the Society of California Archivists, on the handling and preservation of historical documents.

Fiscal Impact:

The maximum grant request is \$10,000. Matching funds through in-kind services will amount to \$2,500 or 100 hours of volunteer time.
